Purpose: This bulletin rescinds 1 Memorandum (Memo) and 2 letters that are no longer applicable

under any code. Additionally, this bulletin conditionally rescinds 1 Memorandum (Memo) and 2 letters that are not applicable to projects filed under the 2014 New York City Construction

Codes.

The Department of Buildings is currently in the process of reviewing published Buildings Bulletins (BBs), Policy and Procedure Notices (Technical, Operational, Legal, Administrative, OTCR), and various memoranda, directives, and letters to see if changes are necessary to reflect current Department practice and incorporate new laws and regulations.

Effective immediately, the following documents are to be rescinded:

- Memo dated 12-10-87 Re: Local Law 58/87 Appeal Procedure
- Letter dated 5-15-90 Re: Local Law 58/87 Minimum Door Size
- Letter dated 10-31-90 Re: Local Law 58/87 Vertical/Inclined Wheelchair Lifts

- Memo dated 10-6-88 Re: Required Elevator Openings as per ANSI A117.1-1986 (Local Law 58 of 1987)
- Letter dated 6-29-90 Re: Section 27-357(e), Building Code Reference Standard 4-6, Section 4.9
- Letter dated 5-6-91 Re: Strobe Warning Devices in Sub-Systems

Rescinded documents will not be applicable to any projects after the issuance date of this Bulletin. They will appear on the Department website with the watermark "RESCINDED."
