**Description** – Replacement PTAC and PTHP air conditioning and/or Heat pump units designed to heat or cool a single room. The unit slides into a wall sleeve/opening that has access to the outdoor air. The system contains indoor and outdoor refrigeration coils, fans control air filter and hermetic sealed compressor. The unit is designed to use refrigerant R-22. The units may or may not have electrical heat. Units with model numbers, heating and cooling capacities, are listed below:

**Terms and Conditions:** The above described Reverse cycle cooling –heating units be accepted when utilizing the refrigerant R-22 under the following conditions:

- 1. All equipment shall be furnished with a permanently fixed metal tag stating that if installed in New York City, there shall be compliance with all provisions of Section27-770, subdivision 4, as to maximum sound levels permitted for exterior mechanical equipment.
- 2. All shipments and deliveries of such equipment shall be provided with a metal tag, suitably placed, certifying that the equipment shipped or delivered is equivalent to that tested and acceptable for use, as provided for in Section 27-131 of the Building Code.
- 3. Approval of all electrical equipment, apparatus, materials and devices shall be obtained from the Building before installation.
