Description: FORMAWALL DS, VERSAWALL and VERSAPANEL exterior insulated wall panels comprising minimum 26 gauge coated galvanized steel facings sandwiching a poured-in-place Pentane blown Polyurethane foam plastic core. The maximum field thickness of the insulation material shall be 2 inches for the FORMAWALL DS and VERSAWALL panels and 1-3/4 inch for the VERSAPANEL panels. The panels are to be fastened to noncombustible supports utilizing methods of attachment prescribed by the manufacturer and tested by Southwest Research Institute. Panels shall be separated from the interior spaces by a thermal barrier having at least a one-hour fire resistance rating.

Terms and Conditions: The above described insulated exterior wall panel systems comprising a thermal insulation which is not noncombustible and does not meet the requirements of Code Section 27-335.1 (a) or 27-335.1 (b) for use where noncombustible construction is required, be accepted for use in either new or existing noncombustible construction group I buildings. Installation shall be in accordance with Section 27.335.1 (c) following manufacturer supplied instructions. All shipments and deliveries of such materials shall be provided with a label or tag certifying that the materials shipped or delivered are equivalent to those tested and acceptable for use, as provided for in Section 27-131 of the Building Code.
