Description: Ductless split-system room air conditioners. Model series S1C, S2C, T2C, T3C, and T4C are the outdoor condenser section. Model series WLC/H, CAC/H are the indoor evaporator. The indoor unit consists of fan motor(s), coil, control section and may or may not contain an electric heat element. The outdoor section consists of a fan motor, coil and compressor. The system uses R-22 as a refrigerant. Units' model numbers and their cooling and heating capacities are listed below:

Terms and Conditions: The above-described split-system room air conditioning units are accepted under the following conditions:

- 1. Units shall use only Refrigerant R-22.
- 2. All equipment shall be furnished with a permanently affixed metal tag stating that if installed in New York City within 100 feet of any dwelling unit window, there shall be compliance with all provisions of Section 27-770, as to maximum sound levels permitted for exterior mechanical equipment.
- 3. All shipments and deliveries of such equipment shall be provided with a metal tag, suitably placed, certifying that the equipment shipped or delivered is equivalent to that tested and acceptable for use, as provided for in Section 27-131 of the Building Code.
- **4.** Approval of all electrical equipment, apparatus, materials and devices shall be obtained from the Department's Electrical Advisory Board before installation.
- 5. Units shall be used in compliance with the Energy Conservation Construction Code of New York State.
