#### Reminder:

- The inspection fee per tow truck is \$50. If you are planning to add new tow trucks, you will also need to pay an additional \$600 license fee for each new tow truck.
- If your trucks fail inspection, you must pay a \$50 fee for each tow truck that requires reinspection before you can schedule reinspection. Refer to Tow Truck Inspection Guidelines.
- You must submit a current New York State Department of Motor Vehicles (DMV) Commercial Truck Registration for each vehicle listed.
- The Department of Consumer and Worker Protection (DCWP) will inspect your tow trucks before your business can operate.
- At the inspection you must present a validated New York City Department of Finance Commercial Motor Vehicle Tax Receipt (tax stamp) for each vehicle weighing more than 10,000 pounds.
