## Zoning for Coastal Flood Resiliency

The New York City Department of City Planning (DCP), is proposing a zoning text amendment, Zoning for Coastal Flood Resiliency (ZCFR), to update the Special Regulations Applying in Flood Hazard Areas (Article VI, Chapter 4). ZCFR would improve upon and make permanent the relevant provisions of the current temporary zoning rules, and provide homeowners, business owners, and practitioners who live and work in the City's floodplain the option to design or otherwise retrofit buildings to: (a) reduce damage from future coastal flood events, (b) be resilient in the long-term by accounting for climate change, and (c) potentially save on long-term flood insurance costs. In addition, it would allow resiliency improvements to be more easily incorporated on waterfront sites at the water's edge and in
public spaces, as well as provide zoning regulations to help facilitate the City's long-term recovery from the COVID-19 pandemic and other future disasters. ZCFR would mostly affect New York City's current one percent annual and 0.2 percent annual chance floodplains. However, select provisions would be applicable Citywide (affecting all five boroughs and the City's 59 community districts. ZCFR also includes updates to other sections of the New York City Zoning Resolution (ZR), including the Special Regulations Applying in the Waterfront Area (Article VI, Chapter 2) and provisions within various Special Purpose Districts.
