Such actions are intended to facilitate the redevelopment of the property at 142-150 South Portland Avenue, with a mixed-use, residential, and community facility building with a height of 13 stories containing 100 dwelling units, all designated as affordable housing. According to MIH Option 1, 25 percent of the residential floor area would be affordable to households at an average 60 percent of Area Median Income (AMI), while 30 percent of the residential floor area would be affordable to households at an average of 80 percent AMI, pursuant to Option 2. The development will provide 22,000 square feet of community facility floor area, with church activities on the ground floor and medical offices in the cellar.

The New York City Department of Environmental Protection (DEP), as lead agency, is preparing a voluntary environmental review for the In-City Water Supply Resiliency Project, which includes renewal of DEP's existing Water Supply/Water Withdrawal Permit and the potential future implementation of temporary treatment systems at DEP's existing well stations. The purpose of the project is to meet the City's water supply needs in times of upstate water supply shortage,

due to drought and planned and/or unplanned unforeseen system infrastructure outages. DEP seeks to identify and disclose any potential adverse significant environmental impacts from the Proposed Project. The Proposed Project will not alter current water supply operations and would be employed only under the limited circumstances described in this Draft Environmental Impact Statement (DEIS). The project was reviewed in accordance with the New York State Environmental Quality Review Act (SEQRA) and the City Environmental Quality Review (CEQR) process. DEP has owned, maintained, and operated a groundwater supply system in southeastern Queens since 1996. The Queens Groundwater system is comprised of 44 well stations, which house a total of 68 water supply wells. These wells collectively have a permitted capacity of up to a five-year running average of 22,568 million gallons per year or 62 million gallons per day (mgd), with a 24,807 million gallon maximum in any single year or 68 mgd.

DEP has prepared a voluntary Draft Environmental Impact Statement (EIS) to support DEP's application to the New York State Department of Environmental Conservation (NYSDEC) to renew the existing Water Supply/Water Withdrawal permit for the groundwater system.

The Draft EIS was issued on November 9, 2017, and is available for review on the DEP website at: www.nyc.gov/dep/environmentalreviews.

DEP will hold public meetings to receive public comments on the In-City Water Supply Resiliency Draft EIS, with informal information $\,$ and listening sessions taking place one hour prior to the meeting at the locations noted below:
