SPECIAL USE REGULATIONS

101-11 **Special Ground Floor Use Regulations**

Map 2 (Ground Floor Retail Frontage), in Appendix E of this Chapter, specifies locations where the special ground floor #use# regulations of this Section apply.

#Uses# within #stories# that have a floor level within five feet of #curb level#, and within 50 feet of the #street line#, shall be limited to #commercial uses# listed in Use Groups 5, 6A, 6C, 6D, 7A, 7B, 8A, 8B, 8D, 9, 10, 11, 12A, 12B and 12C, where such #uses# are permitted by the underlying district. In addition, libraries, museums and noncommercial art galleries shall be permitted. In addition, all non-residential #uses# permitted by the underlying district shall be permitted for buildings fronting on Myrtle Avenue between Ashland Place and Fleet Place. A #building's street# frontage shall be allocated Place and Fleet Place. A #building's street# frontage snail be anocated exclusively to such #uses#, except for Type 2 lobby space, entryways or entrances to subway stations provided in accordance with the provisions of Section 37-33 (Maximum Width of Certain Uses). However, loading berths serving any permitted #use# in the #building# may occupy up to 40 feet of such #street# frontage provided such #street# frontage is not subject to curb cut restrictions as shown on #street# frontage is not subject to curb cut restrictions as shown on

Map 5 (Curb Cut Restrictions) in Appendix E of this Chapter.

The regulations of this Section are modified as follows:

(a) Fulton Mall Subdistrict

For #buildings# in the Fulton Mall Subdistrict, Use Group 6A shall not include post offices, dry cleaning, laundry, or shoe and hat repair establishments. Use Group 6C shall not include automobile supply establishments, electrolysis studios, frozen food lockers, loan offices or locksmiths. Use Group 8A shall not include billiard parlors, pool halls, bowling alleys or model car hobby centers. Use Group 9 shall be prohibited except for typewriter stores. Use Group 10 shall not include depositories for office records, microfilm or computer tapes. Use Groups 6D, 7A, 7B, 8B, 8D, 11, 12A and 12C shall be prohibited. Furthermore, no bank or off track betting establishment shall occupy more than 30 feet of frontage at the ground floor of any #building# along the #street line# of Fulton Street. Any establishment that fronts on the #street line# of Fulton Street for a distance greater than 15 feet shall provide an entrance on Fulton Street.

Atlantic Avenue Subdistrict

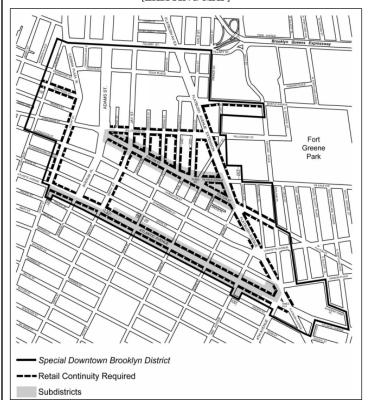
Automotive service stations are not permitted. No bank, loan office, business or professional office or individual #use# in Use Group 9 shall occupy more than 50 feet of linear frontage on Atlantic Avenue. Moving and storage uses in Use Group 7 are permitted on the ground floor of a #building# only if such #use# is located at least 50 feet from the front wall of the #building# in which the #use# is located. Any #buildings developed# after June 28, 2004, or portions of #buildings enlarged# on the ground floor level after June 28, 2004, on a #zoning lot# of 3,500 square feet or more shall have a minimum of 50 percent of the ground #floor area# of the #building# devoted to permitted #commercial uses# in Use Groups 6, 7 or 9, except that this requirement shall not apply to any #development# occupied entirely by #community facility use#

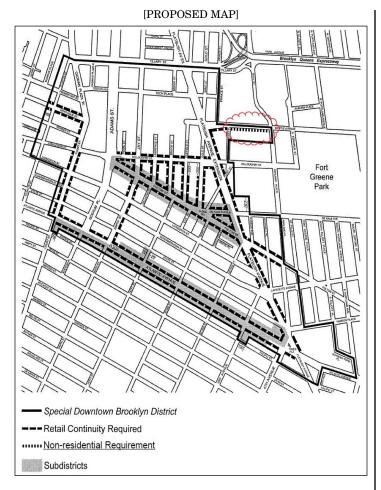
In any #building# within the Atlantic Avenue Subdistrict, the provisions of Section 32-421 (Limitation on floors occupied by non-residential uses) restricting the location of non-#residential uses# listed in Use Groups 6, 7, 8, 9 or 14 to below the level of the first #story# ceiling in any #building# occupied on one of its upper stories by #residential# or #community facility uses#, shall not apply. In lieu thereof, such non- #residential uses# shall not be located above the level of the second #story# ceiling.

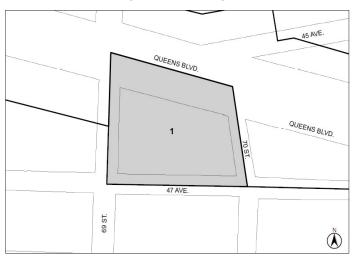

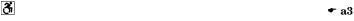

Rigging consists of the system of ropes, slings, hooks, and other hardware used to secure loads while they are being lifted or lowered by a crane or other hoisting machine.

Where can I find DOB's rules? DOB's rules are in Title 1 of the Rules of the City of New York.

What laws govern the rulemaking process? DOB must meet the requirements of Section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of Section 1043(b) of the City Charter.

Statement of Basis and Purpose of Proposed Rule

The Department of Buildings (DOB) is proposing this rule to establish regulations for rigging equipment and rigging operations. Rigging consists of the system of ropes, slings, hooks, and other hardware used to secure loads while they are being lifted or lowered by a crane or other hoisting machine.

The proposed rule adopts national model standards published by the American Society of Mechanical Engineers (ASME) for rigging hardware, hooks, below-the-hook lifting devices, and slings. Additional New York City specific provisions are also proposed. Provisions for inspections, record keeping, and equipment identification are proposed to create a framework to verify compliance with the ASME standards. Restrictions on repairs, alterations, and modifications are provided to ensure these activities are performed in accordance with manufacturer requirements. Other specific precautions for rigging operations and certain types of rigging equipment are proposed to prohibit practices that have led to past rigging failures in New York City.

Adoption of ASME rigging standards, with New York City modifications, was recommended by the Crane Safety Technical Working Group ("TWG"), appointed by Mayor Bill de Blasio and Buildings Commissioner Rick Chandler following the February 2016 crane collapse in Tribeca (TWG recommendation #8).

The Department of Buildings' authority for these rules is found in Sections 643 and 1043 of the New York City Charter and Sections 3316.9 and 3319.9 of the New York City Building Code.

[Deleted material is in brackets.]

"Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

Chapter 3300 of Title 1 of the Rules of the City of New York is amended by adding a new Section 3316-01, to read as follows:

§3316-01 Rigging operations and rigging equipment

- (a) Applicability. This section applies to rigging operations performed in connection with the hoisting or lowering of articles on the outside of a building and all rigging equipment utilized in connection with such operations.
- (b) Definitions. For the purposes of this section, terms defined in Chapter 33 of the New York City Building Code and Section 3319-01 of these rules have the same meaning here.
- (c) Manufacturer specifications, design, and capacity restrictions. Rigging operations must be performed, and rigging equipment utilized, in accordance with specifications and rated capacities established by the manufacturer of the rigging equipment and the manufacturer of the object to be hoisted or lowered. In addition, where plans or design documents are provided, the rigging operations must be performed in accordance with such plans or design documents.

Exceptions: Deviations from the manufacturer specifications and rated capacities are allowed provided they are in accordance with design drawings prepared by a registered design professional who has demonstrated knowledge and experience with rigging. Such design drawings must clearly indicate the deviations from the manufacturer specifications and rated capacities.

- (d) Precautions. The following precautions must be observed during rigging operations.
 - (1) Tag lines. A tag or restraint line must be used where a load could be subject to rotation that would pose a hazard.
 - (2) Releasing the load. The rigging supervisor required by Section 3316.9.1 of the New York City building code is required to ensure that no load is released from the hoisting line or otherwise deposited until either:
 - (i) The load is securely attached in place to the building or structure; or
 - (ii) The load has been placed on a surface or structure capable of supporting the load.
 - (3) Shock loading. Precautions must be taken to avoid shock loading.
 - (4) Makeshift links or fasteners. Makeshift links or fasteners formed from bolts or rods, or other such attachments are prohibited.
 - (5) Job built equipment. Job built rigging equipment must be designed by a registered design professional who has demonstrated knowledge and experience with rigging. Signed and sealed drawings for the job built rigging equipment must be kept at the site at all times.
- (e) Slings. Slings must be utilized in accordance with the requirements of this subdivision and ASME B30.9. Where differences

occur between the provisions of this section and referenced standards, the provisions of this section apply.

- (1) Repairs, alterations, and modifications. Slings may only be repaired, altered, or modified by the manufacturer of the sling, or an entity authorized by the manufacturer.
 - **Exception:** Missing or illegible identification tags may be replaced by a qualified person in accordance with the requirements of the manufacturer of the sling.
- (2) Inspections. The frequent inspection required by ASME B30.9 must be performed prior to each shift by the individual responsible for supervising the rigging operation in accordance with Section 3316.9 of the New York City Building Code. Where synthetic slings are utilized, the softening mechanisms must also be inspected as part of the frequent inspection. The periodic inspection and other inspections required by ASME B30.9 must be performed by a competent person designated by the owner of the sling at the intervals prescribed by ASME B30.9.
 - (i) Additional inspection for synthetic slings. Synthetic materials can be degraded by exposure to sunlight or ultraviolet light. Manufacturer recommendations for the inspection of synthetic slings to determine the damage from sunlight or ultraviolet light must be followed.
- (3) Records. Where ASME B30.9 requires a record or documentation of an inspection or test, such record or documentation must be signed and dated by the individual who performed the inspection or test, and must be maintained by the owner of the sling.
- (4) Identification. Tags or similar identification on the sling must be legible.
- (5) Discarded rope. Discarded rope cannot be used for slings.
- (6) Weakest component. Hooks, rings, oblong links, pear shaped links, welded or mechanical coupling links, or other attachments must have a rated capacity at least equal to that of the sling with which they are used.
- (7) Protection of synthetic slings from edges, corners, or protrusions. Synthetic slings cannot be used unless softening mechanisms have been applied to all edges, corners, or protrusions.
- (8) Use of synthetic slings in conjunction with climber or tower crane erection, jumping, climbing, and dismantling. Synthetic slings can only be used in conjunction with climber or tower crane erection, jumping, climbing, and dismantling if the manufacturer's manual specifically states or recommends the use of synthetic slings.
- (f) Below-the-hook lifting devices. Below-the-hook lifting devices must be utilized in accordance with the requirements of this subdivision and ASME B30.20. Where differences occur between the provisions of this section and referenced standards, the provisions of this section apply.
 - (1) Repairs, alterations, and modifications. Below-the-hook lifting devices may only be repaired, altered, or modified by the manufacturer of the device, or an entity authorized by the manufacturer.
 - **Exception:** Missing or illegible identification tags may be replaced by a qualified person in accordance with the requirements of the manufacturer of the below-the-hook lifting device.
 - (2) Inspections. The frequent inspection required by ASME B30.20 must be performed prior to each shift by the individual responsible for supervising the rigging operation in accordance with Section 3316.9 of the New York City Building Code. The periodic inspection and other inspections required by ASME B30.20 must be performed by a competent person designated by the owner of the below-the-hook lifting device at the intervals prescribed by ASME B30.20.
 - (3) Records. Where ASME B30.20 requires a record or documentation of an inspection or test, such record or documentation must be signed and dated by the individual who performed the inspection or test, and must be maintained by the owner of the below-the-hook lifting devices.
 - (4) Identification. Tags or similar identification on the belowthe-hook lifting device must be legible.
- (g) Rigging hardware. Rigging hardware described in ASME B30.26 must be utilized in accordance with the requirements of this subdivision and ASME B30.26. Where differences occur between the provisions of this section and referenced standards, the provisions of this section apply.
 - (1) Repairs, alterations, and modifications. Rigging hardware may only be repaired, altered, or modified by the manufacturer of the rigging hardware, or an entity authorized by the manufacturer.

Exceptions:

- 1. Missing or illegible identification tags may be replaced by a qualified person in accordance with the requirements of the manufacturer of the rigging hardware.
- 2. Safety latches may be replaced by a qualified person in accordance with the requirements of the manufacturer of the rigging hardware.
- (2) Inspections. The frequent inspection required by ASME B30.26 must be performed prior to each shift by the individual responsible for supervising the rigging operation in accordance with Section 3316.9 of the New York City Building Code. The periodic inspection and other inspections required by ASME B30.26 must be performed by a competent person designated by the owner of the rigging hardware at the intervals prescribed by ASME B30.26.
- (3) Records. Where ASME B30.26 requires a record or documentation of an inspection, calibration, or test, such record or documentation must be signed and dated by the individual who performed the inspection, calibration, or test, and must be maintained by the owner of the rigging hardware.
- (4) Identification. Tags or similar identification on the rigging hardware must be legible.
- (h) Hooks. Hooks must be utilized in accordance with the requirements of this subdivision and ASME B30.10. Where differences occur between the provisions of this section and referenced standards, the provisions of this section apply.
 - (1) Repairs, alterations, and modifications. Hooks may only be repaired, altered, or modified by the manufacturer of the hook, or an entity authorized by the manufacturer. Repairs, alterations, or modifications by welding or reshaping are not acceptable unless prior written approval of the department is obtained.

Exception: Safety latches may be replaced by a qualified person in accordance with the requirements of the manufacturer of the hook.

- (2) Inspections. The frequent inspection required by ASME B30.10 must be performed prior to each shift by the individual responsible for supervising the rigging operation in accordance with Section 3316.9 of the New York City Building Code. The periodic inspection and other inspections required by ASME B30.10 must be performed by a competent person designated by the owner of the hook at the intervals prescribed by ASME B30.10.
- (3) Records. Where ASME B30.10 requires a record or documentation of an inspection or test, such record or documentation must be signed and dated by the individual who performed the inspection or test, and must be maintained by the owner of the hook.
- (4) **Identification.** Tags or similar identification on the hook must be legible.
- (5) Latches and self-locking mechanisms. Hooks without a latch or self-locking mechanism are prohibited.
- (i) Documents made available upon request. Where this section or a referenced standard requires inspection records, design drawings, or other documentation to be maintained, such record, design drawing, or documentation must be made available to the commissioner upon request.
- (j) Referenced standards. The standards referenced in this section are considered part of the requirements of this section to the prescribed extent of each such reference. Where differences occur between provisions of this section and referenced standards, the provisions of this section apply.

NOTICE OF RULE MAKING

Pursuant to the power vested in me as Commissioner of Finance by Section 237 of the New York State Vehicle and Traffic Law, Section 19-203 of the Administrative Code of the City of New York, and Sections 1043 and 1504 of the New York City Charter, I hereby promulgate the rule amending the New York City Department of Finance's ("the Department") rules concerning representatives at Parking Violations Bureau ("PVB") hearings. This amendment revises the time period that a representative may be suspended from appearing before the PVB after a finding that the representative violated one or more Department representative conduct rules. This amendment also adds a new definition relating to brokerage companies. This rule was published in the proposed form on April 19, 2018. A hearing for public comment was held on May 24, 2018.

STATEMENT OF BASIS AND PURPOSE

The Department's Fleet Program is a voluntary program that assists companies with one or more commercial vehicles in obtaining hearings for outstanding parking violation summonses. Similarly, the Department's Car Rental Program is a voluntary program that assists vehicle rental companies in managing parking summonses. Under these programs, when companies receive summonses for their vehicles, they may be represented at hearings in the Department's Commercial Adjudications Unit ("CAU") by their employees or by brokers.

To deter misconduct by representatives who appear at PVB hearings,

this rule authorizes DOF to suspend brokers, brokerage companies and employees of companies that participate in the Fleet Program from appearing before the PVB for any period up to life, after a finding that the representative violated one or more Department representative conduct rules. Examples of rule infractions include attempting to coerce or influence Administrative Law Judges ("ALJs") and submitting fraudulent evidence to ALJs at PVB hearings.

This rule also adds a new definition relating to brokerage companies as this rule extends liability separately to brokerage companies.

Amendments to Rules Relating to Parking Violations

- \S 1. Paragraph (1) of Subdivision (a) of Section 3909 of Chapter 39 of Title 19 of the Rules of the City of New York is amended to read as follows:
- (a)

Brokers. (1) Definitions. Broker. "Broker" means a person who:

- (i) is not the owner or operator of the summonsed vehicle;
- (ii) represents another person or firm;
- (iii) requests a hearing three or more times within any six month period; and
- (iv) is not an employee of the respondent (as defined in § 39-09(b) (1)).
- Brokerage Company. "Brokerage Company" means a corporation,
- company, partnership or entity that: (i) is not the owner or operator of the summonsed vehicle;
- (ii) engages brokers to represent another person or firm; and (iii) requests a hearing three or more times within any six month
- $\$ 2. Paragraph (9) of Subdivision (a) of Section 3909 of Chapter 39 of Title 19 of the Rules of the City of New York is amended to read as
- (9) Penalty for violation of these rules. Any broker or brokerage company who willfully or repeatedly violates these rules may be barred from representing clients at PVB in any capacity. The Commissioner may, after providing notice to the broker <u>and, if the brokerage company is</u> <u>also subject to suspension, the brokerage company,</u> and an opportunity to be heard, suspend the broker for any period up to [five years] life from appearing before the Department in any capacity, except that the broker may appear on parking violations issued in the broker's name, and/or suspend a brokerage company for any period up to and until the dissolution of the brokerage company from appearing before the Department in any capacity, except that the brokerage company may appear on parking violations issued in the brokerage company's name. Such notice(s) will inform the broker and, if the brokerage company is subject to suspension, the brokerage company, of the reasons for the proposed suspension and that the broker and the brokerage company, if the brokerage company is subject to suspension, has the right to present information as to why the broker and/or brokerage company should not be suspended to the Commissioner, or his or her designee, within 10 business days of delivery of the notice by hand or 15 business days of the posting of notice by mail. Any suspension of a broker will apply solely to the broker unless the Department has evidence either that the brokerage company which employed the broker had knowledge of the broker's infractions and did not inform the Department or that the standard practice of [the broker's company] such brokerage company was to commit infractions in its interactions with the Department regardless of the broker involved. Any suspension of a brokerage company will apply to all brokers employed by the brokerage company for the period during which those brokers remain employed by the brokerage company. Any brokerage company shall be barred from representing clients at PVB in any capacity when a broker subject to a life suspension is employed by, engaged by, is subcontracted to, consults with or has any ownership interest in, such brokerage company.
- \S 3. Paragraph (9) of Subdivision (b) of Section 3909 of Chapter 39 of Title 19 of the Rules of the City of New York is amended to read as
- (9) Penalty for violation of these rules. Any employee who willfully or repeatedly violates these rules may be barred from representing his or her employer at PVB in any capacity. The Commissioner may, after or her employer at FVB in any capacity. The Commissioner may, after providing notice to the employee and an opportunity to be heard, suspend the employee for any period up to [five years] <u>life</u> from appearing before the Department in any capacity, except that the employee may appear on parking violations issued in the employee's name. Such notice will inform the employee of the reasons for the proposed suspension and that the employee has the right to present proposed suspension and that the employee has the right to present information as to why the employee should not be suspended to the Commissioner, or his or her designee, within 10 business days of delivery of notice by hand or 15 business days of the posting of notice by mail. Any suspension will apply solely to the employee unless

the Department has evidence <u>either</u> that the standard practice of the employer was to commit infractions in its interactions with the Department regardless of the employee involved <u>or that the employer</u> had knowledge of the employee's infractions and did not inform the Department.

Other procurement methods authorized by law, such as sole source procurements, require notice in the City Record for five consecutive editions. Unless otherwise specified, the agencies and offices listed are open for business Monday through Friday from 9:00 A.M. to 5:00 P.M., except on legal holidays.

NOTICE TO ALL NEW YORK CITY CONTRACTORS

The New York State Constitution ensures that all laborers, workers or mechanics employed by a contractor or subcontractor doing public work are to be paid the same wage rate that prevails in the trade where the public work is being done. The notices for each Agency (or Division) are further divided into three subsections: Solicitations, Awards; and Lists & Miscellaneous notices. Each of these subsections separately lists notices pertaining to Goods, Services, or Construction.

Notices of Public Hearings on Contract Awards appear at the end of the Procurement Section.

At the end of each Agency (or Division) listing is a paragraph giving the specific address to contact to secure, examine and/or to submit bid or proposal documents, forms, plans, specifications, and other information, as well as where bids will be publicly opened and read.
