

Statement of Basis and Purpose of Final Rule

The Environmental Control Board held a Public Hearing on March 29, 2012 regarding amendments to its Department of Buildings (DOB) Penalty Schedule found in Section 3-103 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York (RCNY). Neither written comments nor oral testimony were presented at the March 29, 2012 Public Hearing.

This amendment has lowered the default penalties on two charges in the penalty schedule. These penalties were published incorrectly when the rule was originally promulgated; this amendment has corrected that error.
