During the Communication from the Speaker segment of this Meeting, the Speaker (Council Member Johnson) asked for a Moment of Silence in memory of the following individuals:

On February 14, 2018, a mass school-shooting took place at Marjory Stoneman Douglas High School in Parkland, Florida where seventeen individuals lost their lives and another seventeen were wounded. The Speaker (Council Member Johnson) offered his thoughts and prayers to the victims and their families as well as to the all of the students, faculty, and staff of the high school. He also acknowledged that thoughts and prayers were not enough in the wake of this eighteenth school shooting of 2018. The Speaker (Council Member Johnson) called upon the President of the United States and the Congress to act to ensure that these tragedies are prevented in the future.

Felix Palacios, a former staff member of the Council's Community Engagement Division, passed away in February 2018. Mr. Palacios was born and raised in Brooklyn. He came to public service through his work with the Districting Commission of the early 1990s. Mr. Palacios subsequently joined the staffs of former Council Members Angel Rodriguez and Sara Gonzalez of the 38<sup>th</sup> Council District which is presently represented by Council Member Menchaca. For over twenty years, he was committed to serving the neighborhoods of Red Hook, Sunset Park, Greenwood Heights and portions of Windsor Terrace, Dyker Heights and Borough Park. The Speaker (Council Member Johnson) noted that Mr. Palacios's wonderful smiling grin and knowledgeable social and political discourse would be sorely missed.

**Item 1: 2524-26 Adam Clayton Powell Boulevard**

2524-26 Adam Clayton Powell Boulevard, located in Harlem consists of one building with 18 two-bedroom rental units. 7th Avenue Housing Development Fund Corporation (“HDFC”) acquired the property on December 30, 2015. Under the proposed project, 7th Avenue Lemor LLC will be the beneficial owner and will operate the property. The HDFC and the LLC will receive a loan from the Department of Housing Preservation and Development (“HPD”) for the rehabilitation of the property. In addition, the HDFC and the LLC will enter into a regulatory agreement with HPD establishing that two of the units will be rented to households earning up to 50% of the Area Median Income (“AMI”), nine of the units will be rented to households earning up to 60% of AMI, and seven units will be rented to households earning up to 120% of AMI.

In order to facilitate the project, HPD is requesting that the Council approve, pursuant to Section 577 of the Private Housing Finance Law, a full, 40-year property tax exemption that will be coterminous with the term of the regulatory agreement.

**Item 2: Jamaica Crossing**

Jamaica Crossing is a new construction project that will consist of 1 building with 129 units (including one superintendent's unit) of rental housing for low- and moderate-income households. The project is being developed under HPD's Mixed Income Program under which sponsors construct or rehabilitate multifamily buildings in order to create affordable rental housing with a range of affordability.

On November 24, 2015, the Council approved Resolution 916 approving a full, 40-year exemption from real property taxes pursuant to Section 577 of the Private Housing Finance Law. On December 15, 2016, the Council approved Resolution 1336 making certain technical amendments to Resolution 916. HPD is now requesting that the Council approve further technical amendments to the prior resolutions to clarify that any portions of the building devoted to business or commercial use or community facility space are not exempt from taxation.

  - f. “HDFC” shall mean 7th Avenue Housing Development Fund Corporation or a housing development fund company that acquires the Exemption Area with the prior written consent of HPD.
  - g. “HPD” shall mean the Department of Housing Preservation and Development of the City of New York.
  - h. “Owner” shall mean, collectively, the HDFC and the Company.

- i. “Regulatory Agreement” shall mean the regulatory agreement between HPD and the Owner establishing certain controls upon the operation of the Exemption Area during the term of the Exemption.
2. All of the value of the property in the Exemption Area, including both the land and any improvements (excluding those portions, if any, devoted to business, commercial or community facility use), shall be exempt from real property taxation, other than assessments for local improvements, for a period commencing upon the Effective Date and terminating upon the Expiration Date.
3. Notwithstanding any provision hereof to the contrary:
  - a. The Exemption shall terminate if HPD determines at any time that (i) the Exemption Area is not being operated in accordance with the requirements of Article XI of the Private Housing Finance law, (ii) the Exemption Area is not being operated in accordance with the requirements of the Regulatory Agreement, (iii) the Exemption Area is not being operated in accordance with the requirements of any other agreement with, or for the benefit of, the City of New York, (iv) any interest in the Exemption Area is conveyed or transferred to a new owner without the prior written approval of HPD, or (v) the construction or demolition of any private or multiple dwelling on the Exemption Area has commenced without the prior written consent of HPD. HPD shall deliver written notice of any such determination to the Owner and all mortgagees of record, which notice shall provide for an opportunity to cure of not less than sixty (60) days. If the noncompliance specified in such notice is not cured within the time period specified therein, the Exemption shall prospectively terminate.
  - b. The Exemption shall apply to all land in the Exemption Area, but shall only apply to a building on the Exemption Area that exists on the Effective Date.
  - c. Nothing herein shall entitle the HDFC, the Owner, or any past owner to a refund of any real property taxes which accrued and were paid with respect to the Exemption Area prior to the Effective Date.
4. In consideration of the Exemption, the owner of the Exemption Area shall, for so long as the Exemption shall remain in effect, waive the benefits of any additional or concurrent exemption from or abatement of real property taxation which may be authorized under any existing or future local, state or federal law, rule or regulation.

At a meeting of the Committee on Finance of the City Council of the City of New York (the "City Council") on February 15, 2018, the Committee on Finance considered a communication, dated February 14, 2018, from the Office of Management and Budget of the Mayor of the City of New York (the "Mayor"), of a proposed request, attached hereto as Exhibit "1" (the "Modification"), to modify units of appropriation and transfer city funds in the Fiscal Year 2018 expense budget as adopted by the Council on June 6, 2017, and modified on September 27, 2017 and January 16, 2018, pursuant to Section 107(b) of the Charter of the City of New York (the "Charter").

Analysis. The Council annually adopts the City's budget covering expenditures other than for capital projects (the "expense budget") pursuant to Section 254 of the Charter. On June 6, 2017, the Council adopted the expense budget for Fiscal Year 2018 (the "Fiscal 2018 Expense Budget"). On September 27, 2017, and again on January 16, 2018, the Council modified the expense budget for Fiscal Year 2018. This Modification reallocates appropriations that were reflected in the Fiscal 2018 Expense Budget, by transferring \$2.6 million from the Miscellaneous Budget (unit of appropriation 003) to the Department of Small Business Services (unit of appropriation 011) for construction safety training.

The net effect of the Modification is zero. For more detail on the funding transfer between agencies, see Appendix A of the report attached hereto as Exhibit "1".

Procedure. If the Mayor wishes to transfer part or all of any unit of appropriation to another unit of appropriation from one agency to another; or when a transfer from one unit of appropriation to the another, and such transfer results in any unit of appropriation being increased or decreased by the greater of five percent or \$50,000, section 107(b) of the Charter requires that the Mayor must first notify the Council of the proposed action. Within 30 days after the first stated meeting of the Council following receipt of such notice, the Council



may disapprove such proposed action. If the Council fails to approve or disapprove such proposed action within such 30-day period, the proposed action becomes effective and the Mayor has the authority to make such transfer.

Description of Above-captioned Resolution. In the above-captioned resolution, the Council would approve the Modification pursuant to Section 107(b) of the Charter. Such resolution would take effect as of the date of adoption.

## **REPORTS:**

### **I. INTRODUCTION**

On February 15, 2018, the Committee on Immigration, chaired by Council Member Carlos Menchaca, held a public hearing and vote on Resolution No. 182, which calls upon the United States Congress to pass, and the President to sign, H.R. 4937, which would provide immigration relief for New York resident Ravidath “Ravi” Lawrence Ragbir and denounces the unlawful targeting of immigrant rights activists for deportation by the U.S. Immigration and Customs Enforcement (ICE). Advocates and stakeholders were invited to testify about the challenges immigrant communities face, and the continued need to defend the first amendment rights of community activists and leaders. The resolution passed with four votes in the affirmative and three votes in the negative.

### **II. BACKGROUND**

In February 2017, the Department of Homeland Security (“DHS”) issued new immigration enforcement guidelines no longer exempting classes or categories of “removable aliens” from potential detention and deportation.<sup>1</sup> This directive was a notable departure from previous immigration enforcement policies that prioritized individuals with significant criminal history for deportation, effectively putting all non-citizens at higher risk of deportation. In Fiscal Year 2017, Immigration and Customs Enforcement (“ICE”) officers

apprehended 143,470 immigrants.<sup>2</sup> More immigrants were arrested in the months immediately following the new DHS guidance than in all of Fiscal Year 2016.<sup>3</sup>

In light of the new directive, there was a significant rise in ICE arrests of immigrants with no criminal record, as well as those with only minor, low-level offenses.<sup>4</sup> The directive also led to the increase in apprehension of individuals, with final orders of removal, who had been allowed to stay in the United States due to their strong ties to their communities and lack of serious criminal history, and conditioned on check-ins in with ICE.<sup>5</sup> The roughly 900,000 individuals present in the United States under these supervision requirements, are again vulnerable to deportation as reports show an increase in immigrants detained at once routine ICE check-ins.<sup>6</sup> In the midst of increased immigration arrests and deportations, the Washington Post, the New York Times, and many other major media outlets reported a series of high-profile ICE arrests of prominent immigrant rights activists, alleging that they may have been politically motivated.

Ravidath “Ravi” Lawrence Ragbir, activist and Executive Director of the community organization the New Sanctuary Coalition of New York was detained during the course of a regular check-in with ICE, without any prior notice, and despite both his pending challenge to the criminal conviction underlying his deportation order and his tireless work on behalf of immigrants across the nation. Up until the time of his recent detention, Ravi followed the terms of his deferral of deportation by attending regular check-ins with ICE, paying taxes, and abiding by the law.<sup>7</sup> Ravi was released on January 29, 2018 when Federal Judge Katherine Forrest of the Federal District Court for the Southern District of New York found his detention without warning unnecessarily cruel, stating “there is, and ought to be in this great country, the freedom to say goodbye.”<sup>8</sup> On February 6, 2018, United States Representative Nydia M. Velázquez introduced H.R.4937, legislation that would provide relief for Ravidath Lawrence Ragbir by renewing his eligibility for an immigrant visa or for status adjustment to permanent residence.<sup>9</sup>

Like Ravi, other highly visible immigration activists have been abruptly detained and deported in spite of their strong ties to the United States and positive contributions to their communities.<sup>10</sup> Jean Montreuil, activist and co-founder of the New Sanctuary Coalition of New York, was detained at his regular check-in and quickly deported to Haiti, a country still struggling to recover from recent natural disasters and health epidemics.<sup>11</sup> Eliseo Jurado, husband to an immigrant rights activist in Colorado, was picked up by ICE at the grocery store and has been placed into deportation proceedings.<sup>12</sup> Maru Mora Villalpando, an immigrant rights activist in Washington, has been warned by mail from ICE that she may soon be deported.<sup>13</sup>

On February 8, 2018, Ravi filed a lawsuit in federal court alleging that ICE is selectively targeting immigrant rights activists for removal and claiming that such conduct violated his rights under the First Amendment.<sup>14</sup> Ravi was granted a temporary stay of deportation pursuant to this new First Amendment lawsuit. Despite his release from ICE custody and temporary deferral of deportation, his profound support from elected officials, faith leaders, and community members and his pending claims for relief, Ravi remains at risk of deportation.

### III. CONCLUSION

Expansive deportations and the detention of immigrants cause significant harm and trauma as families are torn apart and individuals are often repatriated to countries to which they no longer have strong ties or where their safety may be at risk. The deportation and detention of highly visible advocates not only has a destabilizing effect on immigrant communities, it can also be construed as politically motivated based on the activists' outspoken positions contrary to current policy. Community leader and activist Ravi Ragbir engenders the need for compassionate, fair and just immigration policies and the protection of First Amendment rights for all New Yorkers.

*Accordingly, this Committee recommends its adoption.*

## INTRODUCTION AND READING OF BILLS

Int. No. 598

By The Speaker (Council Member Johnson), Chin and Constantinides.

### **A Local Law to amend the administrative code of the city of New York, in relation to requiring that all city-owned buildings be powered by green energy sources by 2050**

*Be it enacted by the Council as follows:*

Section 1. Chapter 2 of title 4 of the administrative code of the city of New York is amended by adding a new section 4-211 to read as follows:

*§ 4-211 Green energy in city-owned buildings. a. As used in this section:*

*Green energy sources. The term “green energy source” means a source of energy that is:*

*1. A qualified energy resource, as such term is defined in section 45 of title 26 of the United States code in effect on January 1, 2017;*

*2. A source that is determined to be renewable by the head of an agency designated by the mayor;*

*3. A source that is determined by such head to have (i) a positive environmental impact or (ii) a substantially lower negative environmental impact than fossil fuel-based energy sources.*

*Green energy system. The term “green energy system” means a system that generates energy (i) substantially from one or more green energy sources, in accordance with rules promulgated by an agency designated by the mayor, or (ii) wholly from one or more green energy sources.*

*b. 1. On and after January 1, 2030, not less than 50 percent of the energy used by city-owned buildings shall be (i) generated from a green energy system installed on the premises of such a building or (ii) purchased by the city and generated from a green energy system that is not installed on the premises of such a building.*

*2. On and after January 1, 2040, not less than 75 percent of energy used by city-owned buildings shall be (i) generated from a green energy system installed on the premises of such a building or (ii) purchased by the city and generated from a green energy system that is not installed on the premises of such a building.*

*3. On and after January 1, 2050, 100 percent of energy use by city-owned buildings shall be (i) generated from a green energy system installed on the premises of such a building or (ii) purchased by the city and generated from a green energy system that is not installed on the premises of such a building.*

*c. No later than three months after each compliance date set in subdivision b of this section, the commissioner of citywide administrative services shall electronically submit to the mayor and speaker of the council, and make publicly available online, a report concerning the implementation of this section, including, but not limited to, the following:*

*1. The percentage of energy used by city-owned buildings that comes from green energy sources;*

*2. Any difficulties in complying with this section and recommendations for addressing such difficulties;*

*3. The types of green energy sources utilized and recommendations for expanding or limiting the definition of green energy sources in this section, if any;*

*4. The costs attributable to complying with this section; and*

*5. Reductions in greenhouse gas emissions attributable to complying with this section, including any other environmental or energy-related benefits attributable to such compliance.*

*d. The mayor shall include in each long-term sustainability plan required by subdivision e of section 20 of the charter a plan with policies, programs and actions to be undertaken to comply with the requirements of this section.*

*§ 2. This local law takes effect immediately.*

## Int. No. 599

By The Speaker (Council Member Johnson) and Council Members Deutsch and Borelli.

**A Local Law to amend the administrative code of the city of New York, in relation to requiring the fire department to conduct outreach and education to residential buildings**

*Be it enacted by the Council as follows:*

Section 1. Chapter 1 of title 15 of the administrative code of the city of New York is amended by adding a new section 15-132 to read as follows:

*§ 15-132 Residential education and outreach. a. The department shall make a good faith effort to directly contact owners and occupants of R-2 multiple dwellings to ensure that appropriate fire safety procedures, resources, and educational materials are in place. These efforts shall include, where appropriate, (i) ensuring compliance with fire code section 408.9 and applicable department rules relating to owners providing notice to occupants of fire safety measures, (ii) providing fire safety and fire prevention educational materials, and (iii) providing relevant training to staff at such dwellings.*

*b. Beginning January 1, 2019 and annually thereafter, the department shall electronically submit to the mayor and the speaker of the council and post on its website a report describing the activities taken pursuant to this section during the previous calendar year.*

§ 2. This local law takes effect 120 days after it becomes law, except that the commissioner of fire may take such measures as are necessary for the implementation of this local law, including the promulgation of rules, before such date.

## Int. No. 600

By The Speaker (Council Member Johnson).

**A Local Law to amend the administrative code of the city of New York, in relation to continuation of the public emergency requiring the regulation of residential rents and repealing section 26-520 of such code**

*Be it enacted by the Council as follows:*

Section 1. Section 26-502 of the administrative code of the city of New York, as amended by local law number 26 for the year 2015, is amended to read as follows:

§ 26-502 Additional findings and declaration of emergency. The council hereby finds that a serious public emergency continues to exist in the housing of a considerable number of persons within the [City] city of New York and will continue to exist on and after April [first, two thousand fifteen]1, 2018 and hereby reaffirms and repromulgates the findings and declaration set forth in section 26-501 of this title.

§ 2. Section 26-520 of the administrative code of the city of New York, as amended by local law number 26 for the year 2015, is amended to read as follows:

§ 26-520 Expiration date. This chapter shall expire on April [first, two thousand eighteen]1, 2021 unless rent control shall sooner terminate as provided in subdivision three of section one of the local emergency housing rent control law.

§ 3. This local law takes effect immediately.

## Res. No. 188

**Resolution determining that a public emergency requiring regulation of residential rents in the City of New York continues to exist and will continue to exist on and after April 1, 2018.**

By The Speaker (Council Member Johnson).

**Whereas**, The City, acting by the Mayor, has caused a survey to be made of the supply of housing accommodations and the need for continuing the regulation and control of residential rents and evictions within the City, and such survey has been submitted to the Council in accordance with the law; now, therefore, be it

**Resolved**, That the Council hereby determines that the public emergency requiring the regulation and control of residential rents and evictions within the City continues to exist and will continue to exist on and after April 1, 2018, and that an acute shortage of dwellings continues to exist and will continue to exist on and after April 1, 2018, that such shortage constitutes a threat to the residents of New York City and creates a special hardship to persons and families of limited and moderate means; that unless residential rents and evictions continue to be regulated and controlled, there will be excessive rent increases and evictions for failing to pay such increases, which will produce serious threats to the public health, safety and general welfare, that to avoid such perils to the public health, safety and general welfare, preventive action through local legislation of the City continues to be imperative; that such action, as a temporary measure to be effective until it is determined by the Council that such emergency no longer exists, is necessary in order to prevent threats to the public health, safety and general welfare; that the transition from regulation to a normal market of free bargaining between landlord and tenant, while still the object of State and City policy, must be administered with due regard for such emergency; and be it further

**Resolved**, That the Council of the City of New York, for the reasons hereinabove set forth, hereby determines that the continuation of the regulation and control of residential rents and evictions on and after April 1, 2018 is necessary to protect the public health, safety and general welfare and that such regulation and control should be continued as now or hereafter provided pursuant to the provisions of Chapter 3 of Title 26 of the Administrative Code of the City of New York, subject to such amendment as may be enacted into law.

## Int. No. 601

By The Speaker (Council Member Johnson) and Council Members Richards, Lander, Chin, Rosenthal, Constantinides, and Reynoso.

**A Local Law to amend the administrative code of the city of New York, in relation to requiring the development of a fair affordable housing plan**

*Be it enacted by the Council as follows:*

Section 1. Title 26 of the administrative code of the city of New York is amended by adding a new chapter 21 to read as follows:

**CHAPTER 21**  
**FAIR AFFORDABLE HOUSING PLAN**

*§ 26-2101 Definitions. As used in this chapter:*

*Affordable housing. The term "affordable housing" means a dwelling unit that is required pursuant to a federal, state or local law, rule or program to be affordable for an extremely low income household, a very low income household, a low income household or a moderate income household.*

*Area median income.* The term “area median income” means the median income for households in the city or in the metropolitan area that includes the city.

*Dwelling unit.* The term “dwelling unit” shall have the meaning ascribed to such term in the housing maintenance code.

*Extremely low income household.* The term “extremely low income household” means a household who has an income of no more than 30 percent of the area median income, adjusted for the size of the household.

*Extremely low income affordable housing (ELI-AH) unit.* The term “extremely low income affordable housing (ELI-AH) unit” means affordable housing that is required pursuant to a federal, state or local law, rule or program to be affordable for an extremely low income household.

*Low income household.* The term “low income household” means a household who has an income of more than 50 percent of the area median income but no more than 80 percent of the area median income, adjusted for the size of the household.

*Low income affordable housing (LI-AH) unit.* The term “low income affordable housing (LI-AH) unit” means affordable housing that is required pursuant to a federal, state or local law, rule or program to be affordable for a low income household.

*Moderate income household.* The term “moderate income household” means a household who has an income of more than 80 percent of the area median income but no more than 165 percent of the area median income, adjusted for the size of the household.

*Moderate income affordable housing (MI-AH) unit.* The term “moderate income affordable housing (MI-AH) unit” means affordable housing that is required pursuant to a federal, state or local law, rule or program to be affordable for a moderate income household.

*Supportive housing.* The term “supportive housing” means a dwelling unit, as such term is defined the housing maintenance code, that is required, pursuant to a federal, state or local law, rule or program, to be used as affordable housing for a person with special needs.

*Very low income household.* The term “very low income household” means a household who has an income of more than 30 percent of the area median income but no more than 50 percent of the area median income, adjusted for the size of the household.

*Very low income affordable housing (VLI-AH) unit.* The term “very low income affordable housing (VLI-AH) unit” means affordable housing that is required pursuant to a federal, state or local law, rule or program to be affordable for a very low income household.

*§ 26-2102 Fair affordable housing plan.* The mayor shall, by June 30, 2019, and by June 30 in every year thereafter, submit to the speaker of the council and make publicly available online a fair affordable housing plan providing for the creation and preservation of affordable housing in the city in a manner that affirmatively furthers fair housing throughout the city over the next four years, eight years and twelve years. Such plan shall include, at a minimum:

1. A summary of the current demand for affordable housing and the projected demand for such housing over the next four years, eight years and twelve years, including, but not limited to, the demand for ELI-AH units, VLI-AH units, LI-AH units, MI-AH units and supportive housing;

2. A description of obstacles to fulfilling such demand, including, but not limited to, the price of land and buildings; the availability of federal, state and local financial assistance, including tax benefits, relating to the creation or preservation of affordable housing; requirements, including credit requirements, for applicants seeking to occupy affordable housing; and maintenance costs and other costs associated with affordable housing;

3. (a) The number of ELI-AH units expected to be created pursuant to such plan each year in each neighborhood tabulation area;

(b) The number of VLI-AH units expected to be created pursuant to such plan each year in each neighborhood tabulation area;

(c) The number of LI-AH units expected to be created pursuant to such plan each year in each neighborhood tabulation area;

(d) The number of MI-AH units expected to be created pursuant to such plan each year in each neighborhood tabulation area; and

(e) The number of supportive housing units expected to be created pursuant to such plan each year in each neighborhood tabulation area;

4. (a) *The number of ELI-AH units expected to be preserved pursuant to such plan each year in each neighborhood tabulation area;*

(b) *The number of VLI-AH units expected to be preserved pursuant to such plan each year in each neighborhood tabulation area;*

(c) *The number of LI-AH units expected to be preserved pursuant to such plan each year in each neighborhood tabulation area;*

(d) *The number of MI-AH units expected to be preserved pursuant to such plan each year in each neighborhood tabulation area; and*

(e) *The number of supportive housing units expected to be preserved pursuant to such plan each year in each neighborhood tabulation area;*

5. (a) *The number of ELI-AH units created pursuant to such plan in the preceding year in each neighborhood tabulation area;*

(b) *The number of VLI-AH units created pursuant to such plan in the preceding year in each neighborhood tabulation area;*

(c) *The number of LI-AH units created pursuant to such plan in the preceding year in each neighborhood tabulation area;*

(d) *The number of MI-AH units created pursuant to such plan in the preceding year in each neighborhood tabulation area; and*

(e) *The number of supportive housing units created pursuant to such plan in the preceding year in each neighborhood tabulation area;*

6. (a) *The number of ELI-AH units preserved pursuant to such plan the preceding year in each neighborhood tabulation area;*

(b) *The number of VLI-AH units preserved pursuant to such plan the preceding year in each neighborhood tabulation area;*

(c) *The number of LI-AH units preserved pursuant to such plan the preceding year in each neighborhood tabulation area;*

(d) *The number of MI-AH units preserved pursuant to such plan the preceding year in each neighborhood tabulation area; and*

(e) *The number of supportive housing units preserved pursuant to such plan the preceding year in each neighborhood tabulation area;*

7. *The definitions of “create” and “preserve” used by the mayor for the purposes of this chapter with respect to creating or preserving affordable housing, which definitions shall be established by rule by the mayor or an agency designated by the mayor;*

8. *A list of policies, programs and actions that the city will implement each year in each neighborhood tabulation area to carry out such plan; and*

9. *A description of any substantial changes to such plan made since the submission of the immediately preceding plan and the reasons for such changes.*

*§ 26-2103 Public outreach. In developing the plan required by section 26-2102, the mayor shall consult and meet with representatives of the real estate industry, building owners and managers, affordable housing developers, tenant advocacy organizations, affordable housing advocacy organizations, supportive housing providers, legal service providers and other relevant persons to obtain advice and recommendations. Such plan shall include a description of outreach performed to fulfill the requirements of this section and the advice or recommendations resulting therefrom.*

§ 2. This local law takes effect immediately.

§ 2. Section 27-2005 of the administrative code of the city of New York is amended to add a new paragraph g to read as follows:

*g. It shall be the duty of the owner of a multiple dwelling, which is required to be equipped with self-closing doors pursuant to section 28-315.10, to keep and maintain such doors in good repair.*

§ 3. This local law takes effect immediately.

**§ 15-132 Fire hydrant inspection standards and tracking.** *a. The department shall inspect all fire hydrants maintained by the department of environmental protection at least twice per calendar year, the first inspection occurring prior to April 1st and the second inspection occurring prior to October 1st.*

*b. By February 1st of each year, the department shall post on its website the following information:*

*1. The total number of fire hydrant subject to inspection pursuant to subparagraph a of this section, aggregated citywide and disaggregated by borough and council district;*

*2. The total number of fire hydrant inspections conducted pursuant to subparagraph a of this section during the prior calendar year, aggregated citywide and disaggregated by borough and council district; and*

*3. The location of each inoperable fire hydrant identified through inspection during the prior calendar year, whether the fire hydrant was categorized as a high-priority hydrant by the department, whether the hydrant had been found to have been inoperable during previous inspections within an eighteen month period and whether the department had notified the department of environmental protection that the fire hydrant was determined to be inoperable following an inspection.*

§ 2. This local law takes effect 120 days after it becomes law, except that the commissioner of fire may take such measures as are necessary for the implementation of this local law, including the promulgation of rules, before such date.

**§ 28-312.8 Photoelectric smoke detectors and smoke alarms in group R occupancies.** *On or before January 1, 2019, smoke alarms and smoke detectors shall not be installed within an area of exclusion determined by a 10 foot (3.0 m) radial distance along a horizontal flow path from a stationary or fixed cooking appliance, unless listed for installation in close proximity to cooking appliances. Smoke alarms and smoke detectors installed between 10 feet (3.0 m) and 20 feet (6.1 m) along a horizontal flow path from a stationary or fixed cooking appliance shall be equipped with an alarm-silencing means or use photoelectric detection.*

§ 2. This local law takes effect immediately.

*b. The information required pursuant to subdivision a of this section shall be listed in total and disaggregated by:*

- 1. offense;*
- 2. race;*
- 3. gender;*
- 4. age;*
- 5. borough in which the enforcement action was taken; and*
- 6. the patrol precinct, housing police service area, and transit district in which the enforcement was taken.*

§ 2. This local law takes effect immediately.

Specifically, affirmatively furthering fair housing means taking meaningful actions that, taken together, address significant disparities in housing needs and in access to opportunity, replacing segregated living patterns with truly integrated and balanced living patterns, transforming racially and ethnically concentrated areas of poverty into areas of opportunity, and fostering and maintaining compliance with civil rights and fair housing laws.

§ 2. This local law takes effect immediately.

The department, in coordination with the department of education, shall develop and implement a comprehensive plan for educating both children and parents about fire safety and prevention, including but not limited to public service announcements and outreach in schools about common fire dangers for children and preventative measures to be taken by parents.*

*b. Beginning January 1, 2019 and annually thereafter, the department shall electronically submit to the mayor and the speaker of the council and post on its website a report describing the activities taken pursuant to this section during the previous calendar year.*

§ 2. This local law takes effect 120 days after it becomes law, except that the commissioner of fire may take such measures as are necessary for the implementation of this local law, including the promulgation of rules, before such date.

**A Local Law to amend the administrative code of the city of New York, in relation to stove knob covers**

Section 1. Article 11 of subchapter 2 of chapter 2 of title 27 of the administrative code of the city of New York is amended by adding a new section 27-2046.4 to read as follows:

*§ 27-2046.4 Stovetop protection. a. An owner of a unit in a multiple dwelling, other than a dwelling unit in a multiple dwelling owned as a condominium or cooperative and used as the primary residence of such owner, shall provide, install and maintain stove knob covers on each stove in each dwelling unit in which a child ten years of age or under resides.*

*b. No such owner shall refuse a written request of a tenant or occupant of such dwelling unit to provide, install and maintain stove knob covers, regardless of whether such provision, installation and maintenance is required pursuant to this section.*

*c. Any owner required to provide, install and maintain stove knob covers pursuant to subparagraph 1 of this section who fails to provide, install or maintain a stove knob cover shall be liable for a class C immediately hazardous violation. Notwithstanding any other provision of law to the contrary, the time within which to correct such violation shall be twenty-one days after service of the notice of violation.*

§ 2. This local law takes effect 120 days after it becomes law, except that the commissioner of housing preservation and development may take such measures as are necessary for the implementation of this local law, including the promulgation of rules, before such date.

**A Local Law to amend the administrative code of the city of New York, in relation to prohibiting businesses from setting a minimum purchase requirement greater than \$10 for credit card transactions**

*Be it enacted by the Council as follows:*

Section 1. Chapter 5 of title 20 of the administrative code of the city of New York is amended by adding a new subchapter 20 to read as follows:

*Subchapter 20  
Prohibition of Credit Card Minimum Purchases*

*§ 20-828 Prohibited conduct. It is unlawful for any organization, as such term is defined in section 20-102, to set a minimum dollar value greater than \$10 for the acceptance of credit cards for any sale, lease, rental or loan or offer for sale, lease, rental or loan of any good or service to the public occurring in the city.*

*§ 20-829 Required posting. Any organization that accepts credit cards must conspicuously post on or near any fixed point of sale terminal that credit card minimums greater than \$10 are prohibited by city law. Such disclosure will be in a form determined by the department.*

*§ 20-830 Penalties. a. Any organization violating section 20-828 or any rules promulgated pursuant thereto is liable for a civil penalty of not more than \$150 for the first violation, and a civil penalty of not less than \$1,500 and not more than \$5,000 for each succeeding violation.*

*b. Any organization violating section 20-829 or any rules promulgated pursuant thereto is liable for a civil penalty of not more than \$50 for the first violation, and a civil penalty of not less than \$100 and not more than \$500 for each succeeding violation.*

*c. The department shall commence any proceeding to recover any civil penalty authorized pursuant to the provisions of this section by serving a notice of violation returnable to any tribunal established within the office of administrative trials and hearings or within any agency of the city designated to conduct such proceedings.*

*d. For purposes of this section, all violations committed on any one day by any organization constitute a single violation.*

*e. The department shall design and post to its website a form that the public may use to report a violation of this subchapter.*

*§ 20-831 Enforcement. The department and any other agencies designated by the mayor are authorized to enforce the provisions of this subchapter.*

*§ 20-832 Rules. The commissioner may promulgate such rules and regulations as are necessary for implementing and carrying out the provisions of this subchapter.*

*§ 2. The department of consumer affairs shall educate retail businesses about their obligations pursuant to this local law and any rules promulgated thereto.*

*§ 3. This local law takes effect 120 days after it becomes law.*

**Resolution calling on the United State Supreme Court to protect public sector collective bargaining in *Janus v. American Federation of State, County and Municipal Employees (AFSCME)*.**

By Council Members Torres, Miller, Lander, Rivera and Dromm.

**Whereas**, Collective bargaining is the process in which working people, through their unions, negotiate contracts with their employers to determine terms and conditions of employment, including factors such as pay, benefits, and job health and safety policies; and

**Whereas**, In 1962, President John F. Kennedy granted federal employees the right to collectively bargain by signing Executive Order 10988, leading to a rapid increase in public sector union membership; and

**Whereas**, According to a 2016 news release from the Bureau of Labor Statistics, 7.1 million public sector employees in the United States belonged to a union, representing 34.4 percent of public sector workers; and

**Whereas**, According to the Union Membership and Coverage Database created by Barry T. Hirsch and David A. Macpherson, which uses Current Population Survey (CPS) data, New York State, in 2016, had 967,889

workers in the public sector that were members of a union and/or covered under a collective bargaining agreement, representing 70.2% of all employed workers in the public sector; and

**Whereas**, According to Ruth Milkman, Academic Director of the Joseph F. Murphy Institute for Worker Education and Labor Studies, using CPS data for 18 months spanning January of 2016 to June of 2017, there were 359,255 public sector workers that were members of a union and/or covered under a collective bargaining agreement within New York City; and

**Whereas**, The State of the Unions 2017 report by Ruth Milkman and Stephanie Luce states that New York State's Taylor Law requires every New York State public sector union to represent all members in collective bargaining agreements, including non-union members, allowing these unions to collect mandatory dues and fees to cover the cost of representation for both union members and non-union members; and

**Whereas**, According to the Washington Examiner, the United States Supreme Court has agreed to hear *Janus v. AFSCME*, which deals with the constitutionality of public sector jobs requiring employees, regardless of union membership, to pay a fee (fair-share fee) that covers the union's costs in negotiating contracts for those employees; and

**Whereas**, A ruling in favor of the plaintiff could be a costly setback for public sector unions in 22 states, including New York, where such fees are authorized by law; and

**Whereas**, The United States Supreme Court has ruled on fair-share fees in the 1977 case of *Abood v. Detroit Board of Education*, in which the Court upheld the legality of fair-share fees; and

**Whereas**, In 2016, the United States Supreme Court was deadlocked, with a 4 to 4 vote, on the case of *Friedrichs v. California Teachers Association*, which dealt with fair-share fees; and

**Whereas**, According to the State University of New York (SUNY) Rockefeller Institute of Government, five of New York State's largest public employee unions collected nearly 500 million dollars in 2016 in dues and fees from the employees they represent; and

**Whereas**, If *Janus v. AFSCME* successfully overturns the 40-year old *Abood* Supreme Court Case, automatically deducting dues from employee paychecks could become unconstitutional, causing public sector unions, nationwide, to lose members and revenue, which could diminish union's power to collectively bargain for their workers; and

**Whereas**, The Economic Policy Institute claims that prohibiting fair-share fees could negatively affect millions of public sector workers in efforts to negotiate and improve their terms and conditions of employment; now, therefore, be it

**Resolved**, That the Council of the City of New York calls on the United States Supreme Court to protect public sector collective bargaining in *Janus v. American Federation of State, County and Municipal Employees (AFSCME)*
