#### Agency Description

## Unit Description

In 1982 the New York State Legislature enacted Article 7-C of the Multiple Dwelling Law. This law, known as the New York City Loft Board. The purpose of the law is to regulate the legal conversion of certain lofts units in the city from commercial/manufacturing use to residential use. The New York City Loft Board oversees the conversion of Interim Multiple Dwelling (IMD) buildings to safe residences and compels landlords to bring these spaces up to the minimum standards of the NYS Multiple Dwelling Law and the NYC Construction Codes.

#### Internship Responsibilities

The intern will, under direction and supervision of the Director of Loft Boards:

• Researching Loft Board and court cases

- Attending and participating in "Narrative Statement Conferences" which involve negotiations between landlords and tenants
- Drafting Proposed Orders to the Loft Board based on settlements or reports and recommendations
- Briefing Board members on cases and attending Board meetings
