WHEREAS, the above identified premises were inspected by the New York City Department of Housing Preservation and Development (HPD) on the date noted above; and

pursuant to Health Code §151.02 (d) to eliminate bed bugs and correct any existing conditions conducive to bed bugs in the above referenced unit(s) and any conditions conducive to a bed bug infestation, that may be reported by the occupants of the unit(s) after issuance of this Order as follows:

- 1. Inspect the apartment(s) cited by this order for bed bugs. More information on how to recognize, prevent and control bed bugs can be found on the enclosed flyer or at www.nyc.gov/bedbugs
- 2. If you find a bed bug infestation in the apartment(s),
- a. Inspect all units adjacent to, above and below the infested units, as well as all common areas; and
- b.Retain the services of a pest management professional certified and registered by the New York State Department of Environmental Conservation to take all measures necessary to remove bed bug infestation in the unit(s) cited by this Order and all units and public areas where a bed bug infestation is found during the inspections.
- 3. Keep a record of all actions taken in compliance with this Order.
- 4. Notify the City of your compliance with this Order by certifying as corrected the violation(s) issued by the HPD as directed on HPD's Notice of Violation (enclosed). You can view HPD's violation(s) www.nyc.gov/HPD if you have not yet received the Notice of Violation.
