2	05/02/22–05/13/22	7:00 am to 3:30 pm	<b>East River Park: Greenway</b>	Ongoing Con Edison utility work. Installation of protective fences extending north to E. 10 <sup>th</sup> Street and site preparation, including clearing and grubbing, and removals, see Advisory.
3	05/02/22–05/13/22	7:00 am to 3:30 pm	<b>Corlears Hook Park: Flagpole area</b>	Ongoing site preparation, including clearing and grubbing, and removals. Temporary Bridge installation begins.
4	05/02/22–05/13/22	7:00 am to 3:30 pm	<b>East River Park: Passive Lawn</b>	Ongoing site preparation, including clearing and grubbing. Temporary Bridge installation begins.

Utility work by Con Edison may extend work hours and/or occur on weekends to facilitate utility relocations, maintenance work or inspection services.

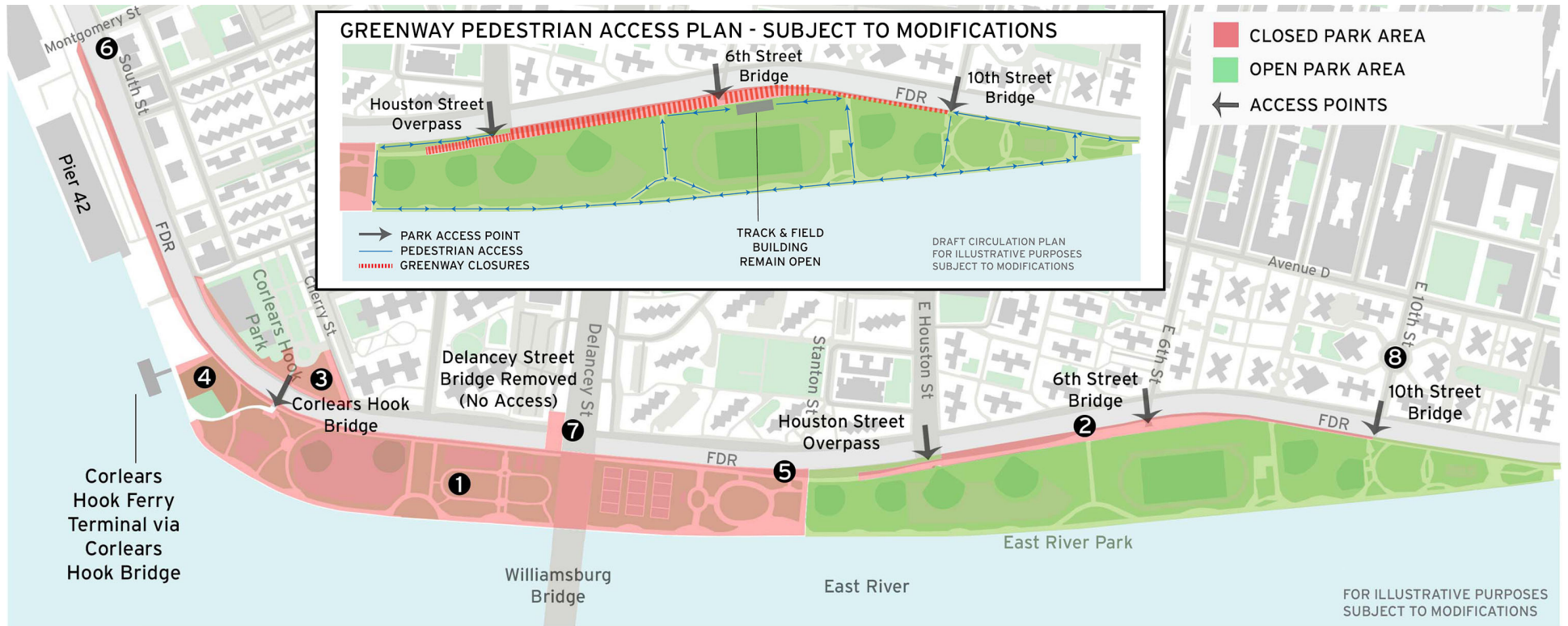
