Supportive Housing in NYC

- New York City has a right to shelter mandate (policy stemming from 1979 court case)
- In 1980's, NYC began working with non-profit providers to develop permanent housing with on-site services by renovating hotels, schools, older/under used apt buildings. Over past 40 years, NYC has developed more than 30,000 units of supportive housing.
- Funding a mix of City, State and Federal sources support development, operations and social services.
- Target populations have primarily included adults with mental health and/or substance use disorders as well as individuals with HIV/AIDS. Populations have expanded to include families with children and young adults at risk of homelessness (aging out of foster care/ homeless with emerging mental health issues).

NYC DSS Roles in Supportive Housing Process

Supportive Housing Eligibility/ Application Review

- HRA processes approximately 20K applications annually.
- Determine Eligibility for all City/State Service Initiatives
- Combination of clinical assessment and administrative data feeds produce a determination that is then used for referral and placement.

Coordinated Entry (Federal Funding Requirement)


- New Database (Coordinated Assessment and Placement System- CAPS) to maintain site and unit details for over 30K supportive housing and community units
- System allows City to monitor a By-Name-List of the most vulnerable clients approved for supportive housing, which in turn facilitates placements
- Service Contracting Agencies are able to verify moves in and out of all tracked supportive housing units to ensure accurate occupancy reporting.

Placement and Referral Office of Supportive/Affordable Housing and Services

- City's designated Agency for referral and placement to a large percentage of NYC Supportive Housing.
- Serve as a liaison between homeless service providers (shelter and street) and supportive housing providers.
- Make referrals of eligible homeless clients to supportive housing units City-wide.


