LOCAL LAW 97 FOR HPD PRESERVATION PROJECTS

Reminder: Many HPD projects > 25,000 sf are subject to Article 321 of Local Law 97¹ (a.k.a. the Prescriptive Pathway") requiring them to demonstrate that they have implemented Prescriptive Energy Conservation Measures (PECMs) or meet published GHG emissions limits by 2024. To assist owners, HPD strongly encourages projects with buildings subject to Article 321* to include all applicable PECMs in project scopes.

PROJECTS SHOULD INCLUDE PECMs IN PROJECT SCOPES IF:

If project includes buildings > 25,000 square feet

If project is an HDFC co-op, includes HUD project-based assistance, or includes > 35% units with rent regulation, AND

Buildings don't currently or are not being designed to meet their 2030 GHG emissions limits by 2024

Incentives are available: The NYS AMEEP Program or Con Ed's LL97 Limited-Time Offer can help offset costs.

NYC Acclerator & KC3 can provide free technical support or help owners procure incentives.

conservation code on or prior to December 31,2024*	
Weatherizing and air sealing where appropriate, including windows and ductwork	
Installing timers on intermittent bath exhaust fans*

* Measure is eligible for an incentive through AMEEP or the Con Ed LL97 Limited-Time Offer

For projects in construction, contingency funds (if available) may be used to fund measures not aleady in scope
