UPON CLOSING OF THIS

TRANSACTION, THE ORIGINAL TRUST INDENTURE WILL BE EFFECTIVELY TERMINATED. THE PRELIMINARY OFFICIAL STATEMENT FOR THESE BONDS HAS ALSO BEEN CIRCULATED TO THE COMMITTEE AND BOARD FOR REVIEW. THE NOT-TO-EXCEED AUTHORIZED AMOUNT IS 525 MILLION. THE EXPECTED ISSUANCE SIZE IS APPROXIMATELY 452 MILLION. THE EXPECTED PRESENT VALUE SAVINGS IS 203 MILLION OR 38% OF REFUNDED PAR AMOUNT, AND THE EXPECTED T. I.C. IS 2.68%. THE LEAD UNDERWRITERS ARE GOLDMAN SACHS AND RAMIREZ. THE EXPECTED INSTITUTIONAL PRICING DATE IS OCTOBER 20, 2021. AND THE EXPECTED CLOSING DATE IS OCTOBER 27, 2021. THE BONDS HAVE BEEN DESIGNATED GREEN BONDS BY KESTREL VERIFIERS. AS THE ISSUANCE OF THE 2022 SERIES "A" BONDS REFUNDS ALL OF THE CORPORATION'S OUTSTANDING 2012 SERIES "A" BONDS AND THE 2012 SERIES "A" BONDS ARE THE ONLY BONDS OUTSTANDING UNDER THE CORPORATION'S ORIGINAL INDENTURE, AFTER THE CLOSING OF THIS TRANSACTION, THE ORIGINAL INDENTURE IS EFFECTIVELY TERMINATED.
