# **FACT SHEETS**:

As suggested, we separated the sale of improvements and sale of rights fact sheets into two different fact sheets. We're still working on them and hopeful that we'll provide them to you at the January Board Meeting. As part of your materials, we sent over the revised fact sheets for the narrative statement. It is our intention to send this fact sheet to each IMD unit when we receive a new registration and a new narrative statement filing. Are there any comments about the narrative statement fact sheet?

We have one pending action at OATH. The case involves 117-119 West 26<sup>th</sup> Street. The staff issued a violation for improper roof drainage. The next conference date is November 16, 2023 and the trial is scheduled for December 14 and 18.
