






FRONT AND REAR ELEVATIONS - REVISED PROPOSAL



NORTH SIDE ELEVATION - PREVIOUS PROPOSAL












STOREFRONT ELEVATION - 1/4" = 1'-0"





STOREFRONT PLAN - 1/4" = 1'-0"








ENLARGED DETAILS - CORNICE











6TH FLOOR PLAN


