Chairperson's Report for December 2013 Catherine McVay Hughes

It has been another extremely busy month for Community Board 1. Together we continue to make our neighborhood better and stronger than ever. I would like to report on the important issues and milestones that we have worked through with fellow board members, the CB1 staff, elected officials and government agencies.

- Concerned Citizens and Business Owners of the Financial District have engaged legal counsel to file a petition under Article 78 of the Civil Practice Law and Rules to request an injunction against the move of the Department of Probation from 346 Broadway to 66 John Street (12/2013)
- NYC Parks Department Renamed Edgar Plaza in Honor of Late Downtown Alliance President Liz Berger with installation of plaque – with Council Member Margaret Chin, Deputy Mayor Patti Harris, Manhattan Parks Commissioner William Castro, Downtown Alliance Chairman Robert Douglass, Downtown Alliance Acting President William Bernstein, and others; NYC Parks will allocate \$2 million to redesign plaza with park to begin construction in 2014 and tentative completion date in 2015 (12/16/2013)
- Summons Court not moving to 71 Thomas Street (12/11/2013)
- The Flea Theater Groundbreaking at 20 Thomas Street \$18.5 million theater complex to include three theaters, offices, costume and scene shops (12/05/2013)
