Chairperson's Report for January 2015 Catherine McVay Hughes

It has been another extremely busy month for Community Board 1 since the December monthly meeting. Together we continue to make our neighborhood better and stronger than ever. I would like to report on the important issues and milestones that we have worked through with fellow board members, the CB1 staff, elected officials and government agencies. We appreciate everyone's efforts and cooperation on the postponement of the Monday, January 26 board meeting due to the blizzard forecast. Thank you everyone!

Updates

- CB1 Special Landmarks Committee Meeting, the second of two, voted on a resolution regarding Landmarks Preservation Commission application by Howard Hughes Corporation for a Certificate of Appropriateness for the following proposals (01/05/15); roughly 200 people attended:
 - 1. Tin Building: relocation and one-story addition
 - 2. Pier 17 western edge/removal of headhouse
 - 3. Pier 17 canopy and mechanical screen
 - 4. Pedestrian canopy
 - 5. Demolition of the Link Building
 - 6. Construction of pavilions and lighting under FDR Drive
 - 7. East River Esplanade
 - 8. New building on Pier 16
 - 9. Schermerhorn Row and new building on John Street
 - 10. Wayfinding dynamic signs
- CDBG-DR funding from the United States Department of Housing and Urban Development (HUD) and Proposed Action Plan Amendment 8
 - At a height of seven feet, CB1 experienced one of the highest inundation levels in Manhattan and unfortunately two people in CB1 drowned and there was billions of dollars of damage to infrastructure, housing and commercial property and utilities
 - City plans to only allocate roughly a total of \$1.5 million to advance resiliency planning and feasibility studies in CB1 and only from Brooklyn Bridge to the Battery Maritime Building out of \$994,056,000 which is the last portion of the City's entire \$4.21 billion grant award
 - It is especially important to study how partially implemented resiliency measures, such as Phase 1 of the BIG U proposal now called the "East Side Coastal Resiliency" which only goes from Montgomery Street to East 23rd Street at \$334 million, would redirect water to surrounding areas such as CB1
 - CB1 is very concerned about the unmet resiliency needs, timeline, implementation and funding for such a proposal for "Compartment C"
 - To date only roughly \$10-20 million has been allocated in Community District 1 (specifically to small business and Build it Back programs, nothing on resiliency)

O NYC EDC recently notified CB1 that it reallocated the \$18 million Neighborhood Game Changer funds to outside of CB1 – CB1 strongly urges City to reallocate these cancelled NYC EDC funds back into CB1's area, specifically into initiatives outlined in the SIRR report such as Coastal Projection "(A) Install an integrated flood protection system in Lower Manhattan" and "(1)" Create an implementation plan and design for an integrated flood protection system for remaining South Manhattan areas" as well as other flood resiliency measures

• CDBG-DR funding from the United States Department of Housing and Urban Development (HUD) and Proposed Action Plan Amendment 8 – although the event was posted as a "Public Hearing," it consisted of a presentation and the public was not allowed to speak at all, but only allowed to submit testimony (Educational Alliance, 197 East Broadway, Manhattan 01/15/15)
