Chairperson's Report for July 2014 Catherine McVay Hughes

It has been another extremely busy month for Community Board 1. Together we continue to make our neighborhood better and stronger than ever. I would like to report on the important issues and milestones that we have worked through with fellow board members, the CB1 staff, elected officials and government agencies. Thank you everyone.

Updates

- Continued to work on the opening of a Greenmarket on Greenwich Street at Albany and converting the former 9/11 Memorial queuing area to a temporary public plaza; working with Lower Manhattan Development Corporation, Downtown Alliance, Mayor's Office, NYC Department of Transportation, NYC Police Department, Grow NYC and Port Authority of NY and NJ
- Continued to work on improving pedestrian and vehicular flow around 9/11 Memorial Plaza with PANYNJ, Mayor's Office, Downtown Alliance and 9/11 Memorial; opened sidewalk along Route 9A along edge of plaza, increased signage and worked on opening of Cortlandt Way with the PANYNJ
- Transportation Planning Certification Review Public Meeting/Listening Session For New York Metropolitan Transportation Council raised concerns for CB1 (07/17/2014)
- Seaport Working Group presentation and discussion of June 2nd Open House and Online Survey Response by Jonathan Martin; findings suggest broad support (91% approval rating overall) for the guidelines and principles as presented, based on 2,367 comments from approximately 250 individuals (including local businesses, organizations, and workers, and other NYC residents); 71% overall approval rating for Guideline 6 suggests moderately strong support in favor of limiting building height and protecting the low-rise character of the Seaport area; Guideline 7 on Resiliency received the strongest support with 98% of respondents identifying resiliency as a matter of paramount importance (06/14/2014)
- HRPT Air Rights Meeting New York State has heeded community concern and has stopped pursuing a General Project Plan (GPP) for Pier 40; NYS has finally recognized that the Hudson River Park legislation that enabled the sale of air rights did so by explicitly empowering the City's own land use process (ULURP). This ensures that local representatives have a say in any change to local zoning, and gives the Community Board a voice in the process as well as the City Council and the Borough President (06/27/14)
- Governor's Island Plaque Dedication to Speaker Silver for his work (06/25/14)
- 3 WTC Board of Directors of the Port Authority of NY and NJ voted to approve the proposed modification to the PANYNJ/SPI 2010 agreement to release \$159 M of SPI's

insurance which was previously sequestered for other purposes to be used for construction of 2 WTC; one provision of the deal calls for up to 50 M of these funds to be immediately released to SPI to jumpstart vertical construction (06/25/14)
