Chairperson's Report for November 2013 Catherine McVay Hughes

It has been another extremely busy month for Community Board 1. Together we continue to make our neighborhood better and stronger than ever. I would like to report on the important issues and milestones that we have worked through with fellow board members, the CB1 staff, elected officials and government agencies.

Milestones

- DOE's Capital Plan includes funding for two schools with 456 seats each in Subdistrict 2, which includes Tribeca, the West Village and Battery Park City; one school location of the two new schools is right outside the CB1 catchment area in the Trinity development site on the north side of Canal Street (6th Avenue and West Broadway) (11/20/2013)
- First step in a long public review process that CB1 will lead on Howard Hughes Corporation's plan for further revitalization of the historic Seaport area (11/19/2013)
- Vesey Street Bridge Removal almost complete; cross Route 9A at grade (11/2013)
- Park Completion Ceremony completion of first phase of new Governors Island Park which includes 30 acres of new park which will open in May 2014 and planting the 800,000th tree in the Mayor's MillionTreesNYC initiative – with Mayor Bloomberg, NYC Commissioner of Parks and Recreation White, Senator Squadron, Trust for Governors Island President Koch and others (11/14/2013)
- Following up on actions dealing with the court relocation from 346 Broadway, local tenants have filed with Civil Supreme Court to stop summons court from moving into 71 Thomas Street (11/14/2013)
- Ribbon-Cutting of 4 WTC attended (11/13/2013)
- East Midtown Plan to rezone 73 blocks of East Midtown Manhattan buildings larger than the Chrysler Building withdrawn by the current administration (11/12/2013)
- Opening of the World Trade Center West Concourse by The Port Authority of New York and New Jersey, Westfield Group and Brookfield Office Properties – major WTC Pedestrian Corridor to open for first time since September 11, 2001; Key pedestrian link will improve access for tens of thousands of daily travelers between the World Trade Center site, Brookfield Place and NY Waterway Ferry Terminal (10/24/2013)
