

Chairperson's Report for August and September 2014 Catherine McVay Hughes

It has been another extremely busy two month for Community Board 1 since the July monthly meeting, although there were no CB1 August meetings. Together we continue to make our neighborhood better and stronger than ever. I would like to report on the important issues and milestones that we have worked through with fellow board members, the CB1 staff, elected officials and government agencies. Thank you everyone.

Updates

- U.S. Senate and House lawmakers from across the country introduce critical reauthorization of James Zadroga 9/11 Health and Compensation Act. Health and compensation programs passed into law after almost a decade-long fight are set to expire next year. Participants in 9/11 health program are living in all 50 States and 429 of 435 Congressional Districts; HR. 5503 in the House of Representatives and S. 2844 in the Senate (09/17/14)
- Installation of new NYC DOT stop sign coming to busy Financial District intersection at the corner of William and John Streets; thank you Pace students for the comprehensive traffic study that produced results, Deron Charkoudian and Ro Sheffe for recommending this traffic study for the Fidi area, elected officials and NYCDOT; passed July resolution (09/15/14)
- South Street Seaport Update: Seaport Working Group meeting (possibly 10/08/14 to be confirmed); CB1 Special Landmarks Meeting to review Howard Hughes Corporation (HHC) LPC application for properties within historic district (10/22/14); HHC Landmark Preservation Commission Hearing (11/18/14)
- Opening of R Train's East River Montague Manhattan-Brooklyn Tube after getting \$250 million in repairs after it was damaged by Hurricane Sandy (09/15/14)
- Continued improvements to pedestrian and vehicular flow around WTC due to CB1 working with agencies
 - First pedestrian streets opened in WTC site are "Cortland Way" and sidewalk along east side of 4 WTC, thanks PANYNJ (early August), closed temporarily for sidewalk shed installation
 - o Increased signage (Church/Cortland Way, Liberty/Route 9A, northern portion of WTC site near Route 9A (early August)
 - Opened side walk along Route 9A edge of Memorial Plaza (end of July)
- Peck Slip Plaza Old Seaport Alliance in partnership with CB1, City agencies (NYCDOT, DPR, DDC) and with help from elected officials, continued to improve the area; east staging area has been cleaned up (August), barricades will be removed and the space will be paved by NYCDOT with funding from DPR in the next few weeks to establish a second temporary plaza; view corridor restored through/under bridge (September/October); working on next steps
- CB1 District Needs Report FY 2016 submitted to NYC City Planning and posted on CB1 website (08/04/14)

• 346 Broadway – elected officials who comprised of the original Task Force, which include both the NYC Council Member and Borough President, are working on issues that need to be resolved. We understand that the community space is getting less space than previously promised to the community. Peebles Corporation which bought the building will be coming before the Planning and Landmark Committees for an update. No news yet on where Summons Court will move. CB1 and elected officials have been asking for an update from the City for months on this issue.
