# Review and approval of September 2019 Community Meeting Summary

Riva Kelton made a motion to approve the September Community Meeting Summary. The motion was seconded by Tierra Labrada and passed by unanimous voice vote.

## **Announcements**

Joey Lopez (Ali Forney Center) announced that Ali Forney's Share NYC application was approved to develop 36 units of supportive housing for youth. He thanked HPD for the opportunity.

Rob Robinson (NESRI) reminded attendees to tell CUNY Staff that they are attending the 'Housing and Housing Services' meeting on the 9<sup>th</sup> floor so that they are directed to the correct floor and room in the building.

Michael Brydges (DSS) announced that the ability to upload into HMIS was restored this week. Providers are expected to complete their monthly upload by Wednesday, October 23<sup>rd</sup>.

## **CoC Website Demo**

Jocelyn Bennett (DSS) gave a walk-through of the new CoC website. The website features information on all key CoC topics, provides resources and helpful links, and is fully accessible with translation and audio-visual accomodations.

## **HMIS Policies and Procedures - Appendices**

Charlie Winkler (DSS), William Lang (Geel), and Melissa Stevenson (DSS) announced that the Data Management Committee met on October 11<sup>th</sup> to review the HMIS Policies and Procedures Appendices. The Committee made minor formatting tweaks to make the Appendices more user friendly. These Appendices must be updated and completed annually. William Lang made a motion to appoint Melissa Stevenson as Co-Chair of the Data Management Committee. The motion was seconded by Catherine Trapani, and passed by unanimous voice vote.

Alyson Zikmund made a motion to approve the HMIS appendices as reviewed and approved by the Data Management Committee, and sent to the Steering Committee for review. The motion was seconded by William Lang, and passed by unanimous voice vote.

Melissa Stevenson made a motion to distribute the HMIS appendices and require that agreements B-F be completed by all HMIS participating organizations (CHO's) by COB Friday, November 1<sup>st</sup>. The motion was seconded by Ronald Fleming, and passed by unanimous voice vote.

# **Governance Implementation Update**

Martha Kenton (DSS) gave a presentation on the Governance Committee's progress towards the implementation of the newly adopted CoC Governance structure. The presentation included a reminder of what will change in the new structure, a proposed meeting schedule for 2020, and a detailed description of the 2020 election process for the restructuredSteering Committee.
