I. Authority Minutes

II. CEO's Remarks

Emergency Rental Assistance Program ("ERAP")/ Rental Arrears

- As of April 30, 2024, tenant arrears totaled \$449 million.
- We are continuing in our final stage of distributing ERAP payments to our residents in partnership with the Office of Temporary and Disability Assistance ("OTDA"). NYCHA submitted payment requests on behalf of 29,071 households, totaling \$156 million. Payments received from OTDA total about \$147 million. ERAP funds have already been distributed to 24,393 resident accounts, totaling over \$144 million.

Public Housing Preservation Trust ("Trust")

- A lot of progress was made since last month; We launched the pre-development planning exercises at Bronx River Addition with a very well attended meeting last week and now officially have sites under predevelopment ahead of converting to the Trust. The Trust, in partnership with NYCHA, has released the Request for Qualifications for Nostrand Houses and Bronx River Addition, the first step in the design build process. This is a major milestone.
- At our next two voting sites, Coney Island and Coney Island 1 Site 1B ("Unity Towers"), we are about halfway through our one hundred (100) days of engagement. Our voting team has held a series of very well attended public meetings and is now shifting to more individual engagement, ensuring that any eligible voter who wishes to can understand both the process and their voting options. Voting will begin on July 17, 2024, and will end on August 15, 2024.

Housing Choice Voucher ("Section 8") Program Waitlist Reopening

For the first time in fifteen (15) years, NYCHA will reopen the waitlist for its Section 8 program. Applications will be accepted from Monday, June 3, 2024 at 12:00 am through Sunday, June 9, 2024 at 11:59 pm. Once the application period closes, NYCHA will randomly place 200,000 applications onto the waitlist via a lottery process. The waitlist is expected to be established by August 1, 2024. NYCHA administers the most expansive Section 8 program in the nation and looks forward to reopening the waitlist for this critical rental subsidy.

Resident Services, Partnerships, and Initiatives Summer Programming – Leroy Williams, Vice-President of Resident Services (Report is attached hereto and incorporated herein)

NYCHA Childcare Business Pathways Program

- <u>Chair Rubin:</u> How much more demand is there than we are supplying for the Childcare Business Pathways Program?
- <u>Leroy Williams:</u> There is far more demand. This is an opportunity for certification and to do it by the book. Overall, the demand is vastly more than we are offering.

NYCHA Youth Build Program

- Member Gavin: Is this the first Youth Build program?
- Leroy Williams: This is not the first Youth Build program, but it is probably the largest.
- <u>Member Gavin:</u> It is a great feeder into our contractors, having that opportunity is super.
- <u>Leroy Williams:</u> It will be in the Brownsville area which is the largest concentration of public housing.
- Chair Rubin: Are these programs funded by NYCHA or by the Community Foundation?
- **Eva Trimble:** The Youth Build is a Federal grant.
- **Chair Rubin**: What about the childcare funding?
- Leroy Williams: I do not know the answer at this moment. I will get back to you.
- **Member Wright:** The Foundation can use more funds; these are great programs.
- Leroy Williams: Yes, for any of these programs, we always need more funds.

Summer Meals Program

- <u>Vice-Chair Gonzalez:</u> Regarding the food programs, who can be contacted to verify that a specific development is cleared or authorized to provide summer meals?
- <u>Leroy Williams:</u> A list can be shared ahead of time. If the list grows, it will be updated and shared as well.

National Night Out

- <u>Vice-Chair Gonzalez:</u> National Night Out events involve residents, the NYPD, and NYCHA taking over the streets. This year the event will take place at a PACT development. Do we get a list of locations for those interested in attending these events?
- <u>Leroy Williams:</u> Yes. NYCHA met with its partners at NYPD regarding these events. We can share the listing with the locations identified to date. The list is fluid and may change. We can share the updated lists as well.

NYCHA's Teen Expansion Program

- <u>Member McKoy:</u> After a conversion occurs, whether involving the Trust or PACT/HUD, are the same programs available?
- <u>Leroy Williams:</u> Yes. Residents in PACT developments have the same opportunities to participate in programs as residents in public housing.

It is a day that brings residents across NYCHA communities together to enjoy fun activities, music, food, and obtain resources geared to strengthening bonds between, families, community and political personalities.

PACT converted sites still host Family Days. If there isn't a Board, the Management team can host the event.

Resident Associations assume full responsibility and supervision of the event being held at their development.

NYCHA staff and partners participate along with elected officials and other city agencies.



Time Frame

Family Day Events must be scheduled between 12:00 pm to 7:00 pm, except where NYCHA/NYPD has placed restrictions.

- > Its highly recommended that guests arrive between the hours of 1:00 pm and 3:00 pm.
- > All music, amplified sound and activities must cease at 6:00pm. For developments with NYCHA/NYPD imposed restrictions, NYCHA will work with the respective Resident Association to determine the hours of the event for the Family Day on a case-by-case basis.
- > NYCHA partners with NYPD to provide oversight of all Family days and take this opportunity to connect with NYCHA residents.

Summer Meals Program

- Entering our 3rd year Resident Services, Partnerships and Initiatives partners with NYC Department of Education and Resident Association Leaders to host the Summer Meals program.
- This program operates Monday Friday from June 27th to August 30th to provide meals for residents 18 years of age and younger only.
- As detailed in the MOU, NYC DOE fully funds NYCHA to hire residents to receive and distribute summer meals at their NYCHA development if they meet the eligibility requirements.
- Eligible developments must be 10 minutes from a NYC DOE school. Developments that are close to a school can pick up and distribute on a voluntary basis.
- We anticipate there will be approximately 15 funded sites operating on NYCHA property this summer.





NYCHA Farms & Gardens

- Approximately 200 NYCHAbased gardeners launched the 2024 season at the "Season of Growth" Summit on April 13th.
- Summer programming at our 9 Farms at NYCHA sites starts June 19, with farmstand kickoff events at the 6 Green City Force operated urban farms.
- Weekly produce distribution and associated programming will be available to residents throughout the summer at all 9 farms.
- The Farms and Gardens unit will support resident gardeners across the city by connecting them to information and technical support.







Community Programs& Facilities

During the summer months in partnerships with DYCD, NYC Aging, and DOE, NYCHA community facilities are open and offer residents of all ages an array of programs.

Community Centers - 130

- Operates summer day camps for youth ages 5 to 12
- July 8 to August 30th, Monday-Friday/8 am to 6 pm

Older Adult Centers - 107

- Operates programs for older adults ages 60+
- Monday-Friday/ 8 am to 5 pm

Day Care Centers - 77

- Operates programs for children ages 3 to 6
- Monday-Friday/ 8 am to 5 pm







Teen Expansion Program

- NYCHA's Teen Expansion Program will operate from July 8th to August 30th for teens and young adults ages 13-24
- ➤ Located at 123 NYCHA community centers and open 7 days a week. Monday—Friday: 6:00 pm to 11:00 pm Saturday & Sunday: 3:00 pm to 11:00 pm.
- > Projected activities and curriculum range from:
 - Visual and performing arts, spoken word and open mics, sports, workforce development, educational & personal development workshops, computer labs, culinary arts, movie and game nights or hours, reducing acts of violence & anti-violence programming*, conflict resolution & mediation, meditation & yoga, special events & field trips.
- ➤ In partnership with NYPD Community Affairs' Officers are assigned to each community center to engage in programming with NYCHA's youth.





Summer Youth Employment Program

- > SYEP offers a NYCHA preference across its community application process under its MAP to Success and CareerFIRST programs, providing career and workforce opportunities to youth ages 14 to 24 who reside in one of the below developments.
- > Youth will earn the NYS minimum wage of \$16.00 an hour and may work up to 25 hours per week for six weeks in July and August.
- > RSPI secures worksites at NYCHA departments for youth enrolled in SYEP. Currently there are 39 worksites with 181 positions available.

NYCHA Childcare Business Pathways Program

- The NYCHA Childcare Business Pathways program is a 15- week free program created for public housing and Section 8 voucher holders to start and grow successful home-based childcare businesses as part of NYC's efforts to support entrepreneurs and increase licensed childcare providers.
- 25 residents will participate in the next cohort which will begin the first week of July 2024.
- Participants receive required childcare business training and certifications.
- Assistance in completing their NYS childcare license application.
- Free professional business training and one-on-one coaching.





NYCHA Youth Build Program

- NYCHA has recently been awarded a \$1.38M by the US. Department of Labor (DOL) FY24 YouthBuild grant to provide training and employment services in an ongoing effort to expand access to apprenticeship opportunities, prepare young workers for quality jobs and strengthen the nation's workforce to meet industry demands.
- > The NYCHA YouthBuild Program will serve 60 NYCHA residents ages 16-24 from the Brownsville-Ocean Hill neighborhood of Brooklyn, New York (Brooklyn Community Board 16) who left high school prior to graduation and who have barriers to employment. The program will run in two six-month cohorts of 30 students. Each cohort will include:
 - Technical, lab and hands-on classroom construction skills and construction safety training leading to industry-recognized certifications and credentialing, including OSHA, Site Safety Training, and National Center for Construction Education and Research (NCCER) Construction Technology Credentials,
 - Hands-on construction skills application through the renovation of up to 3 vacant NYCHA units,
 - High School Equivalency (HSE) instruction and career readiness support to successfully pass the HSE exam and prepare for career and/or post-secondary success,
 - Leadership development, including community service opportunities
 - 12-months of job placement, supportive services and post-program follow-up support. Participants will receive a stipend and other wrap around services support while in the program.
