Approval of Minutes of Meeting of December 19, 2018

Recommendation to the Board of Directors - Approval of Supplemental Resolution No. 143

Authorizing the issuance of Fiscal 2019 Series EE Second General Resolution Water and Sewer System Bonds

The next item on the agenda was the recommendation to the Board of Directors of

the Authority that they approve of Supplemental Resolution No. 143 Authorizing the Issuance of

the Fiscal 2019 Series EE Second General Resolution Water and Sewer System Bonds. Mr.

Anders introduced Olga Chernat, Executive Director of the Authority, who explained that the

proposed resolution authorizes the issuance of up to \$500 million of fixed rate bonds, but expects

to issue approximately \$390 million and has built in a cushion to accommodate fluctuating

market conditions. She explained that this is a competitively bid refunding, with a not to exceed

True Interest Cost of 5%, and approximately \$80 million net present value savings, or 18% of the

refunded par. She noted that the expected bid date is February 27, 2019, and the closing is

expected to be March 20, 2019. There being no discussion, upon motion duly made and

seconded, the following resolution was adopted.

WHEREAS, pursuant to the New York Public Authorities Law, the Finance Committee of the New York City Municipal Water Finance Authority (the "Authority") is charged with reviewing proposals for the issuance of debt by the Authority and making

recommendations to the Board; and

WHEREAS, the Finance Committee has received and reviewed a proposal for Supplemental Resolution No. 143 authorizing the issuance of the Authority's Fiscal 2019 Series EE Second General Resolution Water and Sewer System Bonds (the "Bonds"); it is therefore

RESOLVED, that the Finance Committee recommends to the Board of Directors approval of

Supplemental Resolution No. 143 authorizing the issuance of the Bonds.
