

The Mayor's Office to End Domestic and Gender-Based Violence (ENDGBV) develops policies and programs, provides training and prevention education, conducts research and evaluations, performs community outreach, and operates the New York City Family Justice Centers. The NYC Family Justice Centers are co-located multidisciplinary service centers providing vital social services, civil legal, and criminal justice assistance for survivors of domestic and gender-based violence and their children—all under one roof.

This is the second annual report to be provided in compliance with Local Law 40 of 2019, covering the time period July 1, 2020 through June 30, 2021. This report provides an overview of responses from the Family Justice Center Client Satisfaction Survey. During this time period, 419* surveys were collected, 71 in the Bronx, 98 in Brooklyn, 43 in Manhattan, 65 in Queens and 141 in Staten Island.

1. WHAT SERVICES DID YOU RECEIVE TODAY? (PLEASE SELECT ALL THAT APPLY) (N=419)





EXAMPLES OF WHAT RESPONDENTS FOUND MOST HELPFUL:

"My case manager helped me get the police record and the criminal court protection order, and also helped me arrange consultations with a divorce lawyer, and also gave me spiritual support, which made me feel there is hope in my life."

"I truly appreciate being able to have my session via video. The pandemic has been a huge strain on my mental health. Being able to see my therapist regularly via telemedicine has been the driving factor in survival for me."

"What is always helpful for me is: I can trust the FJC therapist and all staff. I feel secure and my daughter as well. My daughter also receives tutoring from an amazing woman. She meets with my daughter every Monday. I would never be able to afford this if it were not for the FJC. I am forever thankful for all the help and support we get from FJC."

"I really liked how they resolved my immigration status in such a short time. The lawyer was very kind and very understandable. The aid I received was all excellent. I thank you for all the support many blessings for the entire department. \mathcal{A} God bless you."

"The language, I can explain my situation in my language Hindi and Urdu. [The case manager] can understand why I am afraid to share my and daughter story, and she is giving me motivational advises regarding my career growth too during the other DV services."

"This place is amazing. Going through a very hard time with people that care about your situation and do everything they can to help you make things a little bit easier."
