## ······ SHERIDAN EXPRESSWAY UPDATE

Governor Cuomo and State elected officials announced \$700 million in this year's State budget to alter the Sheridan Expressway between Westchester Avenue and the Cross Bronx Expressway, implementing elements of a 2013 proposal *(link to plan here: http://www1.nyc.gov/assets/planning/download/pdf/plans-studies/sheridan-hunts-point/final full report.pdf*) to develop Sheridan Boulevard, thereby providing direct access to the Bronx River waterfront and new ramps into Hunts Point to improve access to the markets and remove trucks from local streets. The City, along with the Southern Bronx River Watershed Alliance and other groups, is working to understand the State's design and how it supports the community's stated goals of improving pedestrian safety, access to the waterfront parks, and overall neighborhood health and vitality.

To date, about 250 surveys have been completed. The Dept. of City Planning (DCP) continues to seek opportunities to engage the public and will continue to provide access to the online survey, distribute printed copies to organizations, and meet members of the community where they are through tabling events. Building upon the recommendations of the planning partners, DCP began to engage in small group meetings in March, seeking to meet residents and stakeholders where they are. The summary of those meetings is below:

#### **Banana Kelly Resident Leadership Meeting** *830 Fox Street*

DCP staff were invited to Banana Kelly's monthly Resident Leadership meeting to discuss the Southern Blvd neighborhood study. Staff from the Department of Housing Preservation & Development joined us as well. After a brief presentation on the planning process, participants engaged in a frank discussion around housing concerns. Fear of displacement, the need for truly affordable housing, and homelessness in the area were particularly prevalent concerns. DCP looks forward to continuing this conversation and to working with the community to address these issues and to ensure that the planning process is transparent, open, and welcoming.

#### **Neighborhood Shopp Casa Boricua Senior Center** 910 E 172nd Street

For this small group meeting, City Planning staff teamed with the Department of Cultural Affairs to hold a workshop helping to identify concerns specific to the senior community. Participants helped to identify existing assets in the community and engaged in visioning activities and elaborations of key values that will help to shape the study as it moves forward.



#### Southern Boulevard Business Improvement District (BID) Casita Maria, 928 Simpson Street

City Planning staff, together with Small Business Services, held a small group meeting focused on the concerns of merchants in the Southern Boulevard Neighborhood BID. The workshop offered an opportunity to better understand barriers and opportunities to promoting a diverse and vibrant retail and business environment in the corridor.
