The City suspends alternate side parking (ASP) regulations, for both street cleaning purposes and traffic flow, on these legal and/or religious holidays in February 2021. Non-metered residential side streets that have multiple ASP days will be cleaned – with vehicles required to be moved- only on the latest day in the week on each side, until further notice. Accordingly, parking meters will not be in effect on major legal holidays<sup>\*</sup>.
