## Call to Order:

Chairman Alvin Warshaviak called this Board Meeting to order at 7:30 p.m.

## Public Participation:

<u>Anthony Lemma</u> spoke about all of the ways in which Assemblyman David Weprin is continuously advocating for what's important to our community.

- Assemblyman Weprin worked together with Governor Cuomo and passed legislation that will boost our economy, create jobs and cut taxes.
- More money in the pockets of working families by extending a middle-class personal income tax reduction for three more years. Working families will benefit from the creation of a \$350 tax credit per child for families with incomes between \$40,000 and \$300,000.
- Advocated and passed funding for full-day and half-day pre-kindergarten programs.
- This past Tuesday, Assemblyman Weprin organized a hearing on mayoral control in schools. He introduced a bill that would reform mayoral control on schools by giving parents and teachers greater involvement in the education decision making process. The Panel for Education Policy would appoint the Chancellor rather than the Mayor to restore checks and balances in the system.
- Assemblyman Weprin has been tirelessly fighting to support Martin Van Buren High School against co-location. It is important for all of us to come out to the Martin Van Buren High School Co-Location Public Hearing which will be held at the school at 6:00 p.m. on Wednesday, October 23, 2013.

YAIP will give these young adults paid internships, training and hope for a probable job outcome. Chairman Alvin Warshaviak announced that he is glad to see everyone present for the Board Meeting.

# **District Manager's Report**

District Manager's Report was distributed.

The staff and I are working on the business forum scheduled for **Thursday**, **November 21**, **2013** at the Hillcrest Jewish Center. We are surveying the business owners to find out the best time to hold the meeting (between 5 p.m. to 9 p.m.). So far, a few Board Members showed interest in helping and we are looking for more volunteers.

There was no District Service Cabinet meeting this month, as it conflicted with the Borough Budget Consultations. Here is some important information from the agencies that we met with recently.

<u>HPD</u> – Discussed the Mortgage Assistance Program. Homeowners can receive up to \$25,000 with 0% interest to help modify or pay off mortgages (see flyer). They have several housing projects on the way; however, none are in CB8. They do seal up buildings. The initial request needs to come from the Department of Buildings.

 $\underline{\text{DOT}}$  – There is still no funding to do curbs alone. All curbs are done in conjunction with sidewalk repairs. The District Managers discussed requesting that the City Council members draft legislation that would allow homeowners to deduct the cost of curb repair from their property tax over a three year period. This request would be sent once we have a new administration. The street resurfacing allocation has increased by 50% this fiscal year. The resurfacing list will be given at a later date. NYCDOT is mandated by the state to clean the state highway but they are not receiving the state funding to do so.

<u>NYPD</u> – We were given a breakdown by Community Board the number of personnel allocated to each precinct. The 107<sup>th</sup> had a total of 2 Captains, 7 Lieutenants, 16 Sergeants, 12 Detectives, 125 uniformed officers and 16 civilians. They discussed the big wheel program and asked that we direct our complaints to our commanding officers.

 $\underline{DOB}$  – The agency is working towards a 5 day turn around for certain complaints from community boards and elected officials. The stall site program (*for stalled construction sites*) is voluntary and is due to sunset on October 13<sup>th</sup> this year. There are 583 stalled sites citywide and about 18% of them are in Queens (165). They discussed interagency initiative to address SRO complaints. They devised 35 factors amongst them foreclosure, owing taxes etc... to give these locations special attention. There is a 15 day turn around on these complaints. They discussed the different procedures for unsafe building and emergency declaration. The first one is done within a 45 day period while the other happens immediately.

Building owners must do annual analysis (Benchmarking Reports) of their energy use and submit it on May 1<sup>st</sup> of each year if they meet the following criteria:

- Buildings greater than 50,000 square feet (check the Department of Finance's website for building size)
- A tax lot that contains two or more buildings that exceed 100,000 square feet
- Two or more buildings held in a condominium form together are more than 100,000 square feet

**New Service** – With funding from Councilman Mark Weprin and the collaboration of CUNY Citizenship Now, we will have free immigration assistance twice a month at Community Board 8. A lawyer will be at our office from 10 a.m. to 4 p.m. on the **first** and **third Friday** of every month until June 2014. The lawyer will answer questions related to Naturalization and Deferred Action for Childhood Arrivals. Please call ahead for an appointment and spread the word!

<u>James Gallagher</u> shared with the Board that the Fresh Meadows Library will be closing for 4-5 months effective Saturday, October  $12^{\text{th}}$ . They are located on  $194^{\text{th}}$  Street and the Horace Harding Expressway. They are doing renovations inside the library including new scanning machines.

<u>Marc Haken</u> asked what specific services the immigration assistance program will be providing. District Manager Marie Adam-Ovide reiterated that CUNY Citizenship Now will answer questions related to Naturalization and Deferred Action for Childhood Arrivals.

<u>Community Affairs Officer Peter Capozzi</u> distributed enrollment postcards so that the community can enroll in the  $107^{th}$  Precinct's mass mailing list. This is a free service. The community can receive all the breaking news in the five Boroughs as well as with the  $107^{th}$  Precinct.

The Community Board was also introduced to the Crime and Prevention Officer Brian Dietzel of the 107<sup>th</sup> Precinct.

## Borough President's Representative – Susie Tanenbaum

- Susie helped explain "Deferred Action for Childhood Arrivals". To be considered for a "Deferred Action for Childhood Arrivals", you had to have been brought over with your parents from another country. You would have had lived most of your life here. This is the only country you know. You must meet specific criteria. You must be enrolled in a higher education, or have performed military service for the United States.
- Borough President Helen Marshall extends her condolences to the Board on the passing of Board Member Maurice Braithwaite. He was an outstanding Board Member. He was a very dignified man and he was multi talented. We will miss him greatly.
- Congratulations to Carolyn Baker-Brown on her new position as Community Board Executive Secretary.
- This month is Domestic Violence Awareness Month. Borough President Helen Marshall is sponsoring two workshops. One has already taken place. The next one is on Wednesday, October 23, 2013: 10: 00 a.m. – 12:00 noon in Room 213 at Borough Hall. It will address the impact that domestic violence has on our communities and finding solutions through spirituality. It will be an interfaith workshop.
- Borough President Marshall reminds homeowners to take steps to ensure they keep receiving their tax exemption. Homeowners who receive the Basic Star property tax exemption from the State of New York now have to register with the NYS Tax Department in order to receive the exemption in 2014 and in subsequent years.

\*Marc Haken has concerns with the STAR property tax exemption letters that went out to co-ops. The letters did not have apartment numbers on them. The mailmen returned the letters and the shareholders never received the letters. He would like the Borough President to be aware of this situation as well as the various representatives from our elected officials. This has become a major problem for the co-ops.

- Borough President Marshall encourages eligible consumers to enroll for lifeline discount telephone service. It is an initiative to make basic telephone service more affordable for qualified consumers by saving them up to \$250 a year on their home telephone bills. This is really for low income community residents and people who are on federal assistance programs.
- Susie also shared with us that in addition to working full time, she is attending grad school. We wish her much success!

<u>Marc Haken</u>: The #1 Priority that the Community Board has put down for the last several years has been to "Increase or maintain personnel for the 107<sup>th</sup> Precinct." We have no chance of getting additional police officers unless they are authorized by the City. They are going to do what they are going to do. He is suggesting that this #1 item not be listed anymore on the "Expense Priority" list.

<u>Carolann Foley:</u> The Precinct loves what this Community Board does for them. Unfortunately, we have no input into the number of personnel for the  $107^{th}$  Precinct. She agrees this "Expense Priority" should be taken off the list. We are wasting a spot.

<u>Mark Lefkof</u>: As Chair of the Public Safety Committee, he totally disagrees with this view. We have to do this. Officers are cut every year. We have no other way. This is the way we are able to express our total dissatisfaction.
