Maria DeInnocentiis introduced Mr. Robert Callahan from Michael Kelly Inc. Mr. Callahan is the expeditor for Cinque Fratelli, Inc. The owner could not be present due to other business related concerns.

Questions and Comments by the Board:

<u>Marc Haken</u> asked what the restaurant is planning to do. Answer: <u>The owners are cutting the size of the café in half. They were licensed for 20 tables and 41seats. The business never warranted that many tables and seats. The number of tables is being reduced to 10 tables and 20 seats.</u>

<u>Mr. Haken</u> asked if there were any violations against the company. Answer: <u>No violations. No music outdoors.</u> The owner will basically be operating the way he has been operating.

Kevin Forrestal asked that we confirm there are no active complaints on the restaurant. It was confirmed.
