MINUTES OF THE MEETING OF GOVERNANCE COMMITTEE

September 5, 2018

A meeting of the Governance Committee (the "Committee") of the Sales Tax Asset Receivable Corporation (the "Corporation") was held on September 5, 2018 at approximately 2:24 p.m. at 255 Greenwich Street, Room 6M4, New York, New York.

Scott M. Stringer, Comptroller of the City, represented by Michael Stern;

Corey Johnson, Speaker of the City Council, represented by Davis Winslow;

Zachary Carter, Corporation Counsel of the City, represented by Al Rodriguez;

Emily Newman, Acting Director of the Mayor's Office of Operations, represented by George Davis, III; and

Jacques Jiha, Finance Commissioner, represented by Jacqueline Gold, constituting a quorum of the Board. Michael Moore served as secretary of the meeting.

Also in attendance were members of the public, officers of the Corporation and employees of various agencies of the City.

The meeting was called to order by Mr. Rodriguez, Chairperson of the Committee.

Approval of Minutes

The first item on the agenda was the approval of the minutes of the meeting of the Committee held on April 27, 2018. Upon motion duly made and seconded, there being no objections, the following resolution to adopt such minutes was approved.

WHEREAS, the Governance Committee has reviewed the minutes of the previous meeting of the Governance Committee held on April 27, 2018; it is therefore

RESOLVED, that the minutes of the Governance Committee meeting of April 27 2018, are hereby approved.

<u>Self-Evaluation of the Governance Committee and Discussion of Presentation to Board of Directors</u>

The second item on the agenda was the self-evaluation of the Committee and discussion of the presentation to the Board of Directors of the Corporation. Mr. Rodriguez explained that Section III(g) of the Committee Charter requires an annual self-evaluation of the functioning of the Committee. He noted that the report with respect to the functioning of the Committee was contained in the packet provided to the members of the Committee. He described the resolution set forth below which expresses the opinion of the Committee that its functioning has been satisfactory and which authorizes the presentation of the report to the Board of Directors. A motion was made to approve such resolution. The motion was seconded and, there being no objections, approved.

WHEREAS, Section III(g) of the Governance Committee Charter requires the Governance Committee to conduct an annual self-evaluation of its functions; and

WHEREAS, the Governance Committee finds its functioning and performance to be satisfactory, effective, and in compliance with the Governance Committee Charter; it is therefore

The third and final item on the agenda was a review of compensation and

Committee Charter. He further explained that the Corporation has no employees and referred to

the material in the packet provided to the Committee members that describes the Corporation's

reimbursement to the New York City Municipal Water Finance Authority and the City's Office

of Management and Budget for the services of their employees.
