Steve Elie-Pierre of the New York City Department of Environmental Protection presented the PS-317 Victory Boulevard Pumping Station Project. The address of the pumping station is 4435 Victory Boulevard, Staten Island, NY 10314. It was constructed in 1989 (32 years old). Due to the age and deteriorating conditions of the station, it has been identified to be in need of a full rehabilitation/reconstruction. The presentation is on the Board's website at cb2si.com.

Steven Williams presented the N.Y.C. Taxi & Limousine Commission's Accessible Dispatch Program.
