Block #683; Lot #'s 214 & 262

City Planning application numbers (N 210206 ZAR, N 210207 ZAR, N 210209 ZAR, and N 210208 ZAR) submitted by Inna Goldstein for authorization for modification of topography on Tier 1 sites pursuant to ZR Section 105-421, modification of botanic environments and tree preservation requirements pursuant to ZR Section 105-425, and modification of yard, height and setback regulations pursuant to ZR Section 105-432, and for a certification of restoration plans pursuant to ZR 105-45 to address the unauthorized removal of five trees without CPC approval and to facilitate a new two-story, detached, single-family residence with Fire Apparatus Access Road on Block 683, Lots 262 and 214 at Shields Place in R1-1 and R1-2 districts in the Emerson Hill Neighborhood within the Special Natural Area District (NA-1).
