Joseph Breen: Breen Bros. Towing has contracts with government agencies that require strict response time. All towing companies cannot fulfill their obligations due to traffic on West Shore Expressway, particularly the jughandle from Huguenot to Victory Boulevard. He is Traffic Incident Management (TIM) certified. He is advocating for State Law "Steer It Clear It."

Paul B: Traffic on West Castor Place from Powell to Alverson has gotten worse. In October 2019 he attended a Traffic & Transportation Committee meeting at CB3. Many possible solutions were discussed but nothing has been done. The speed cameras on Woodrow Road have made things worse. It is a cut through to avoid the lights and cameras. West Castor Place between Marcy and Alverson is very narrow, 19-21 ft. He would like for that to be a one-way street. He is also asking for a 3-way stop at Marcy and West Castor Place, and at Powell and West Castor Place.

Paul M: Hylan Boulevard and Buffalo Street, entrance to the Great Kills Park. Would like better lighting at the intersection, raised crosswalks. Vehicles turning into the park are turning too fast.
