Owner and Agent each understand they remain independently responsible for compliance with TLC Rules, including those applicable to owning and operating a medallion; and that designating an Agent does not affect an Owner's responsibility to comply with TLC Rules. Owner and Agent further understand that TLC is not a party to, nor involved in any agreement between Owner and Agent for the management of the above Medallion(s); and neither party will rely on TLC to assist with the return of Medallion credentials upon termination of Agent's representation, or for any matter related to Agent's representation. Owner and Agent each affirm and certify that per TLC Rule §63-04(h) and §63-11(g), all taxes and surcharges for the above Medallion(s) while under Agent's management will be collected and remitted to the appropriate parties; and if requested, proof of remitted taxes will be provided to TLC. Owner and Agent each acknowledge that any false statement(s) submitted is punishable under the law, and may result in the denial of an application, or the suspension or revocation of an existing license or permit."
