**Minutes of Commission Meeting**

**July 18, 2006**

1. The Chair called the meeting to order and reported the following:
  - Legislation has passed the N.Y.S. Assembly and Senate, and awaits the Governor's signature, concerning:
    - For-hire vehicle licensing reciprocity among New York City, Westchester and Nassau Counties; (Tr. pp.3-9)
    - Permitting up to (150) additional accessible vehicle medallions to be auctioned at a future sale; and (Tr. pp.9-10)
    - A tax credit of up to \$10,000 for retrofitting for-hire vehicles and other liveries to make them accessible. (Tr. p.10)
  - The TLC denied three petitions for fuel surcharges from three different groups on June 30. A copy of each petition denial was provided to each Commissioner at the Commission Meeting. (Tr. pp.11-15)
  - Two successful medallion auctions were held in June. On June 16, (54) accessible medallions were sold, and on June 22, (254) alternative fuel medallions were sold. (Tr. pp.15-16)
  - The TLC will work with the Mayor's Office for People with Disabilities, as well as its advisory boards, to develop recommendations for two stickers on taxicabs: one to identify accessible cabs and the other to identify clean air cabs. (Tr. pp.18-19)
  - The next Commission Meetings are tentatively scheduled for August 10 and September 14. (Tr. pp.19-20)

2. Commissioner Sander made a motion to adopt the minutes of the June 8, 2006 Commission Meeting. Commissioner Vargas seconded the motion, and it passed unanimously. (Tr. p.28)




