Frequently Asked Questions

Am I successfully enrolled?

It takes at least six weeks for applications to be processed. Any applications received before the first Monday of each month will be processed in this month's enrollment. Owners will receive a missing requirements letter if information is missing and/or does not match TLC records or a notification of successful enrollment by the last week of the month.

Generation Begins

When will I get paid?

TLC will release payments to all eligible owners that have not been flagged by Department of Finance for non-payment and do not have outstanding TIF surcharge balance with TLC. Operational payment generation begins as early as the noted dates and owners will receive hack up payments on the noted dates.

Am I eligible for hack up payment?

You will receive a payment of \$14,000 per vehicle if you are successfully enrolled in the program, your vehicle is a Wheelchair Accessible Vehicle, and TLC never paid a hack up payment to any owners with that VIN.

Am I eligible for operational payment?

You will receive quarterly payments of \$1,000 if you are successfully enrolled in the program, your vehicle is a Wheelchair Accessible Vehicle and 250 trips were performed during each quarter.
